# A BILL FOR AN ACT

RELATING TO THE EMERGENCY AND BUDGET RESERVE FUND.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the national and 2 global economic crisis that began in the second half of 2008 has 3 caused significant economic problems in numerous industries in 4 the state, including the airline, cruise ship, tourist, and 5 construction industries. Mass layoffs have been reported by an increasing number of Hawaii businesses statewide, from the 6 7 agricultural sector to the medical services sector. Hawaii's 8 automobile dealers have cut fifteen per cent of their workforce 9 and that percentage could double in the future. Financial 10 uncertainty has led to fewer visitor arrivals and lower hotel 11 occupancy rates, resulting in layoffs and reductions in employee 12 hours. Furthermore, recent forecasts show that the situation 13 will worsen with a continued decline in employment, personal 14 income, and visitor arrivals, and rising inflation.

15 Difficult economic times and declining tax revenues have 16 resulted in budget cuts for all state services. State 17 departments have been asked to lower their budget proposals by 18 up to twenty per cent. The department of education faces a SB2469 HD1 HMS 2010-2582 Page 2 🛝



possible \$100,000,000 shortfall for the next academic year and funding has been discontinued for science textbooks and materials, literacy training programs for learning-disabled children, as well as for speech pathologists, occupational and physical therapists, and more than two hundred other positions.

6 The department of health has projected a \$25,000,000 7 shortfall for mental health services in the current fiscal year. 8 Funding has been eliminated for the healthy start program, 9 totaling approximately \$22,000,000 for the biennium. 10 Additionally, the governor has discontinued funding for the 11 Hawaii children's health care program, which may leave an 12 estimated one thousand five hundred gap group children without

13 access to affordable health care.

14 The current and impending situation jeopardizes the safety 15 net of basic human services, health, and education needs for 16 Hawaii's residents and families. While all of Hawaii's 17 residents will be affected by the situation, gap group families 18 and families closest to the poverty line will suffer the most. 19 In Act 304, Session Laws of Hawaii, 1999, the legislature 20 established the emergency and budget reserve fund as a temporary

21 supplemental source of funding for the State of Hawaii in times
22 of emergency, economic downturn, or unforeseen reduction in

revenues. As set forth in section 328L-3, Hawaii Revised
 Statutes, specific purposes for the fund include maintaining of
 levels of programs determined to be essential to public health,
 safety, welfare, and education. Act 304 also included certain
 prohibitions on appropriations from the emergency and budget
 reserve fund. Appropriations for the following purposes are
 specifically prohibited:

8 (1) To meet expenses of the legislature;

9 (2) To provide for salary adjustments for officials
10 appointed pursuant to article V, section 6 or article
11 VI, section 3 of the Hawaii Constitution and for
12 others whose salaries are directly related to salaries
13 of these officials; and

14 (3) To fund cost items in any collective bargaining15 contract.

16 The legislature finds that expenditures from the emergency 17 and budget reserve fund are needed to meet the conditions of 18 emergency, economic downturn, and unforeseen reduction in 19 revenues that the State currently faces. Further, the 20 legislature finds that the appropriations in this Act are 21 consistent with the purposes of the emergency and budget reserve 22 fund.
