A BILL FOR AN ACT

RELATING TO THE EMERGENCY AND BUDGET RESERVE FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the national and
2	global economic crisis that began in the second half of 2008 has
3	caused significant economic problems in numerous industries in
4	the state, including the airline, cruise ship, tourist, and
5	construction industries. Mass layoffs have been reported by an
6	increasing number of Hawaii businesses statewide, from the
7	agricultural sector to the medical-services sector. Hawaii's
8	automobile dealers have cut fifteen per cent of their workforce,
· 9	and that percentage could double in the future. Financial
10	uncertainty has led to fewer visitor arrivals and lower hotel
11	occupancy rates, resulting in layoffs and reductions in employee
12	hours. Furthermore, recent forecasts show that the situation
13	will worsen with a continued decline in employment, personal
14	income, and visitor arrivals, as well as rising inflation.
15	Difficult economic times and declining tax revenues have
16	resulted in budget cuts for all state services. State
17	departments have been asked to lower their budget proposals by

up to twenty per cent. The department of education faces a

- 1 possible \$100,000,000 shortfall for the next academic year and
- 2 funding has been discontinued for science textbooks and
- 3 materials, literacy training programs for learning-disabled
- 4 children, as well as for speech pathologists, occupational and
- 5 physical therapists, and more than two hundred other positions.
- 6 The department of health has projected a \$25,000,000
- 7 shortfall for mental health services in the current fiscal year.
- 8 Funding has been eliminated for the healthy start program,
- 9 totaling approximately \$22,000,000 for the biennium.
- 10 Additionally, the governor has discontinued funding for the
- 11 Hawaii children's health care program, which may leave an
- 12 estimated one thousand five hundred gap group children without
- 13 access to affordable health care.
- 14 The current and impending situation jeopardizes the safety
- 15 net of basic human services, health, and education needs for
- 16 Hawaii's residents and families. While all of Hawaii's
- 17 residents will be affected by the situation, gap group families
- 18 and families closest to the poverty line will suffer the most.
- 19 In Act 304, Session Laws of Hawaii 1999, the legislature
- 20 established the emergency and budget reserve fund as a temporary
- 21 supplemental source of funding for the State of Hawaii in times
- 22 of emergency, economic downturn, or unforeseen reduction in

- revenues. As set forth in section 328L-3, Hawaii Revised
 Statutes, specific purposes for the fund include maintaining
- 3 levels of programs determined to be essential to public health,
- 4 safety, welfare, and education. Act 304 also included certain
- 5 prohibitions on appropriations from the emergency and budget
- 6 reserve fund. Appropriations for the following purposes are
- 7 specifically prohibited:
- 8 (1) To meet expenses of the legislature;
- 9 (2) To provide for salary adjustments for officials
 10 appointed pursuant to article V, section 6 or article
 11 VI, section 3 of the Hawaii Constitution and for
 12 others whose salaries are directly related to salaries
 13 of these officials; and
- (3) To fund cost items in any collective bargainingcontract.
- 16 The legislature finds that expenditures from the emergency
- 17 and budget reserve fund are needed to meet the conditions of
- 18 emergency, economic downturn, and unforeseen reduction in
- 19 revenues that the State currently faces. Further, the
- 20 legislature finds that the appropriations in this Act are
- 21 consistent with the purposes of the emergency and budget reserve
- 22 fund.



- 1 Therefore, given the current economic crisis and
- 2 concomitant budget deficit, the purpose of this Act is to
- 3 appropriate moneys from the emergency and budget reserve fund of
- 4 the State of Hawaii to maintain the levels of programs
- 5 determined to be essential to education, public health, and
- 6 public welfare.
- 7 SECTION 2. There is appropriated out of the emergency and
- 8 budget reserve fund of the State of Hawaii the sum of
- 9 \$ or so much thereof as may be necessary for fiscal
- 10 year 2010-2011 for respite services.
- 11 The sum appropriated shall be expended by the department of
- 12 health for the purposes of this Act.
- 13 SECTION 3. There is appropriated out of the emergency and
- 14 budget reserve fund of the State of Hawaii the sum of
- 15 \$ or so much thereof as may be necessary for fiscal
- 16 year 2010-2011 to supplement the healthy start program.
- 17 The sum appropriated shall be expended by the department of
- 18 health for the purposes of this Act.
- 19 SECTION 4. There is appropriated out of the emergency and
- 20 budget reserve fund of the State of Hawaii the sum of
- 21 \$ or so much thereof as may be necessary for fiscal
- 22 year 2010-2011, to provide funding for grants pursuant to

1 chapter 42F, Hawaii Revised Statutes, to be distributed as 2 follows: 3 (1) Catholic Charities Hawaii \$ 4 (2) Kapahulu Center 5 (3) Moiliili Community Center 6 (4) Waikiki Community Center 7 The sum appropriated shall be expended by the department of 8 health for the purposes of this Act. 9 SECTION 5. There is appropriated out of the emergency and 10 budget reserve fund of the State of Hawaii the sum of 11 or so much thereof as may be necessary for fiscal 12 year 2010-2011, for the purposes of maintaining kupuna care 13 services. 14 The sum appropriated shall be expended by the department of 15 health for the purposes of this Act. 16 SECTION 6. There is appropriated out of the emergency and 17 budget reserve fund of the State of Hawaii the sum of 18 or so much thereof as may be necessary for fiscal 19 year 2010-2011 for the Aging and Disability Resource Center.

The sum appropriated shall be expended by the department of

health for the purposes of this Act.

- 20 health for the purposes of this Act.
- 21 SECTION 10. There is appropriated out of the emergency and
- 22 budget reserve fund of the State of Hawaii the sum of



- 1 \$ or so much thereof as may be necessary for fiscal
- 2 year 2010-2011 for direct health care to the uninsured, which
- 3 may include primary medical, dental, and behavioral health care.
- 4 The sum appropriated shall be expended by the department of
- 5 health for the purposes of this Act.
- 6 SECTION 11. There is appropriated out of the emergency and
- 7 budget reserve fund of the State of Hawaii the sum of
- 8 \$ or so much thereof as may be necessary for fiscal
- 9 year 2010-2011, as a substance abuse prevention and treatment
- 10 block grant for substance abuse treatment.
- 11 The sum appropriated shall be expended by the department of
- 12 health for the purposes of this Act.
- 13 SECTION 12. There is appropriated out of the emergency and
- 14 budget reserve fund of the State of Hawaii the sum of
- 15 \$ or so much thereof as may be necessary for fiscal
- 16 year 2010-2011 for the healthy aging partnerships program.
- 17 The sum appropriated shall be expended by the department of
- 18 health for the purposes of this Act.

- 22 on aging base budget.

- 20 appropriations for QUEST health care payments, the sums of
- 21 \$ and \$ respectively, or so much thereof as
- 22 may be necessary for fiscal year 2010-2011 for the restoration

- 2 quest health care payments; provided that the funds shall not be
- 3 expended for any other purpose; provided further that any
- 4 unexpended funds shall lapse to their respective funds; provided
