A BILL FOR AN ACT

MAKING AN APPROPRIATION TO THE HAWAII CIVIL AIR PATROL FOR OPERATING EXPENSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Hawaii civil air
- 2 patrol is a civilian volunteer auxiliary service of the United
- 3 States Air Force. The three missions of the Hawaii civil air
- 4 patrol are providing emergency services, cadet programs, and
- 5 aerospace education. The Hawaii civil air patrol serves the
- 6 state and the nation through homeland security and humanitarian
- 7 efforts and has over five hundred members who provide volunteer
- 8 public service. The Hawaii civil air patrol consists of three
- 9 squadrons and four aircraft on Oahu, one squadron and two
- 10 aircraft on Kauai, one squadron and one aircraft on Maui, and
- 11 two squadrons and two aircraft on the island of Hawaii. All
- 12 volunteers are trained and ready to execute emergency service
- 13 missions, including tsunami warning, search and rescue, damage
- 14 assessment, aerial homeland security support, and counter-drug
- 15 reconnaissance.
- 16 Since the 1950s, tsunami warning has been the Hawaii civil
- 17 air patrol's primary mission in Hawaii. In October 2006, 🗸

- 1 following an offshore earthquake near the island of Hawaii,
- 2 Hawaii civil air patrol units and crews assisted the Hawaii
- 3 county civil defense by taking photographs of damaged sites. In
- 4 November 2006, Hawaii civil air patrol units flew tsunami watch
- 5 sorties over north and west Oahu to warn beachgoers to evacuate.
- 6 In January 2007, the Hawaii civil air patrol alerted beachgoers
- 7 on the Na Pali coast to the possibility of a tsunami. There is
- 8 no other airborne tsunami warning capability in Hawaii outside
- 9 the Hawaii civil air patrol.
- 10 Even more vital is the role that the Hawaii civil air
- 11 patrol plays in providing volunteers for emergency services.
- 12 The Hawaii civil air patrol participates in disaster relief
- 13 operations by augmenting the operations of the United States
- 14 Coast Guard. In July 2002, the Hawaii civil air patrol was
- 15 instrumental in locating a small plane that went down on Maui.
- 16 In February 2004, the Hawaii civil air patrol located a missing
- 17 air ambulance that had crashed near Hilo. In December 2008, the
- 18 Hawaii civil air patrol ran an aerial damage assessment mission
- 19 to assist Kauai civil defense in gauging damage caused by recent
- 20 storms and flooding.
- 21 In addition, the Hawaii civil air patrol has a fully
- 22 developed cadet program that challenges and educates over two



- 1 hundred cadets in leadership, military science, aerospace
- 2 education, emergency services, and citizenship. The cadet
- 3 program includes a summer camp for cadets that provides a
- 4 comprehensive course covering leadership, team-building, drill
- 5 and ceremonies, and exposure to the Hawaii civil air patrol and
- 6 the United States Air Force. Attending the camp is a
- 7 requirement for a cadet to progress through the ranks.
- 8 Recently, the Hawaii civil air patrol, Hawaii Wing has been
- 9 downsized by one aircraft by its national headquarters due to
- 10 the minimum flying of its assigned aircraft. The number of
- 11 tsunami training missions and training flights for the State of
- 12 Hawaii has been minimized and the Hawaii civil air patrol flies
- 13 and trains only on the availability of state civil defense
- 14 funds.
- 15 The legislature finds that the Hawaii civil air patrol
- 16 requires state funding to allow it to continue its vital tsunami
- 17 warning operations.
- 18 The purpose of this Act is to appropriate funds to the
- 19 Hawaii civil air patrol to continue its missions in Hawaii.
- 20 SECTION 2. There is appropriated out of the general
- 21 revenues of the State of Hawaii the sum of \$ or so
- 22 much thereof as may be necessary for the fiscal year 2010-2011

- 1 for the Hawaii civil air patrol to continue its missions in the
- 2 State of Hawaii, including its tsunami warning operations.
- 3 The sum appropriated shall be expended by the department of
- 4 defense for the purposes of this Act.
- 5 SECTION 3. This Act shall take effect on July 1, 2020.
