A BILL FOR AN ACT

RELATING TO LANDOWNER LIABILITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Chapter 663, Hawaii Revised Statutes, is
amended by adding a new section to be appropriately designated
and to read as follows:

4 "§663-Trespass; no duty of care; liability of owner; 5 rebuttable presumption. (a) Notwithstanding any provision in this chapter to the contrary, an owner of land owes no duty of 6 7 care to keep the land safe for entry or use by a trespasser or 8 to give any warning of a dangerous condition, use, structure, or 9 activity on the land to a trespasser. 10 (b) There shall be a presumption that an owner of land is 11 not liable to a trespasser for injury, loss, damage, or death 12 occurring on the premise. (c) In any action for civil damages, the presumption that 13 an owner of land is not liable to a trespasser for injury, loss, 14 damage, or death occurring on the land may be rebutted by a 15 16 preponderance of the evidence that the owner:

- 17 (1) Committed an act or omission that constitutes gross
- 18 negligence or wilful or wanton disregard for the

2	caused the injury, loss, damage, or death; or
3	(2) Intentionally injured the trespasser.
4	(d) As used in this section, unless the context otherwise
5	requires:
6	"Invited guest" means any person specifically invited by
7	the owner or authorized representative of the owner to visit
8	land for social, business, or other purpose.
9	"Land" means land, roads, water, watercourses, private ways
10	and buildings, structures, and machinery or equipment when
11	attached to realty, other than lands owned by the government.
12	"Owner" means the possessor of a fee interest, a tenant,
13	lessee, occupant, or person, group, club, partnership, or
14	corporation in control of the land.
15	"Trespasser" means a person who enters or remains on land
16	without the permission of the owner or the owner's agent and who
17	is not an invited guest."
18	SECTION 2. New statutory material is underscored.
19	SECTION 3. This Act shall take effect on July 1, 2050.
