A BILL FOR AN ACT

RELATING TO INTOXICATING LIQUOR.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Section 281-31, Hawaii Revised Statutes, is
2	amended	by amending subsection (n) to read as follows:
3	" (n)	Class 14. Brewpub license. A brewpub licensee:
4	(1)	Shall manufacture not more than [ten] thirty thousand
5		barrels of malt beverages on the licensee's premises
6		during the license year;
7	(2)	May sell malt beverages manufactured on the licensee's
8		premises for consumption on the premises;
9	(3)	May sell malt beverages manufactured by the licensee
10		in brewery-sealed packages to class 3 wholesale dealer
11		licensees pursuant to conditions imposed by the county
12		by ordinance or rule;
13	(4)	May sell intoxicating liquor[7] purchased from a class
14		1 manufacturer licensee[-] or a class 3 wholesale
15		dealer licensee $[\tau]$ to consumers for consumption on the
16		licensee's premises. The categories of establishments
17		shall be as follows:
18		(A) A standard bar: [or] and



1		(B) Premises in which live entertainment or recorded
2		music is provided. Facilities for dancing by the
3		patrons may be permitted as provided by
4		commission rules;
5	(5)	May sell malt beverages manufactured on the licensee's
6		premises to consumers in brewery-sealed kegs and
7		growlers for off-premises consumption; provided that
8		for purposes of this paragraph, "growler" means a
9		glass container, not to exceed one half-gallon, which
10		shall be securely sealed;
11	(6)	May sell malt beverages manufactured on the licensee's
12		premises [to consumers,] in recyclable containers
13		[that may be] provided by the licensee or by the
14		consumer[, not to] which do not exceed one gallon per
15		container[, which] and are securely sealed on the
16		licensee's premises[7] to consumers for off-premises
17		consumption;
18	(7)	Shall comply with all regulations pertaining to class
19		4 retail dealer licensees when engaging in the retail
20		sale of malt beverages; [and]
21	(8)	May sell malt beverages manufactured on the licensee's

premises in brewery-sealed containers directly to

1		class 2 restaurant licensees, class 3 wholesale dealer
2		licensees, class 4 retail dealer licensees, class 5
3		dispenser licensees, class 6 club licensees, class 8
4		transient vessel licensees, class 9 tour or cruise
5		vessel licensees, class 10 special licensees, class 11
6		cabaret licensees, class 12 hotel licensees, class 13
7		caterer licensees, [and] class 14 brewpub licensees,
8		class 15 condominium hotel licensees, and consumers,
9		pursuant to conditions imposed by county regulations
10		governing class 1 manufacturer licensees and class 3
11		wholesale dealer licensees [-]; and
12	<u>(9)</u>	May conduct the activities described in paragraphs (1)
13		through (8) at one location other than the licensee's
14		premises; provided that:
15		(A) The manufacturing takes place in Hawaii; and
16		(B) The other location is properly licensed under the
17		same ownership."
18	SECT	ION 2. This Act does not affect rights and duties that
19	matured,	penalties that were incurred, and proceedings that were
20	begun bef	ore its effective date.

Intoxicating Liquor; Brewpub Manufacturing

Description:

Increases on-premises brewpub licensee manufacturing limit from 10,000 to 30,000 barrels. Allows brewpub licensees to directly sell liquor manufactured on the premises to other brewpub licensees and to consumers, and to conduct activities at one location other than the licensee's premises. Effective July 1, 2020. (SB2545 HD2)
