## A BILL FOR AN ACT

RELATING TO NET ZERO ENERGY BUILDING PERMITTING.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Net zero energy buildings are designed to
- 2 consume net zero energy use and produce zero carbon emissions.
- 3 Currently, permits for net zero energy buildings are processed
- 4 in the same manner as for other buildings. However, unlike
- 5 other buildings, net zero energy buildings promote the growth of
- 6 energy efficiency and renewable energy in the State. Therefore,
- 7 expediting the permitting process for net zero energy buildings
- 8 would be a no-cost incentive for increasing the design and
- 9 construction of energy-efficient buildings in Hawaii.
- 10 SECTION 2. Chapter 107, Hawaii Revised Statutes, is
- 11 amended by adding a new section to part II to be appropriately
- 12 designated and to read as follows:
- 13 "§107- Net zero energy building design. Not later than
- 14 January 1, 2012, the council shall adopt rules implementing a
- 15 prescriptive design alternative for net zero energy buildings
- 16 that is equivalent to thirty-five per cent more energy efficient
- 17 than is required under the 2006 International Energy

- 1 Conservation Code, as published by the International Code
- 2 Council.
- 3 As used in this section, "net zero energy building" has the
- 4 same meaning as defined in section 196-2."
- 5 SECTION 3. Section 46-15.6, Hawaii Revised Statutes, is
- 6 amended by adding a new definition to be appropriately inserted
- 7 and to read as follows:
- 8 ""Net zero energy building" has the same meaning as defined
- 9 in section 196-2."
- 10 SECTION 4. Section 46-19.4, Hawaii Revised Statutes, is
- 11 amended to read as follows:
- "[+]§46-19.4 Priority permitting process for renewable
- 13 energy and net zero energy building projects.[+] All agencies
- 14 shall provide priority handling and processing for all county
- 15 permits required for renewable energy and net zero energy
- 16 building projects[-]; provided that agencies shall provide
- 17 priority handling and processing for net zero energy building
- 18 projects if the permit applications are accompanied by a
- 19 certificate from an architect or mechanical engineer, licensed
- 20 in the State, verifying that the project is a net zero energy
- 21 building.

1 For purposes of this section, "agencies" means any 2 executive department, independent commission, board, bureau, 3. office, or other establishment of a county, or any quasi-public 4 institution that is supported in whole or in part by county 5 funds." SECTION 5. Section 196-1.5, Hawaii Revised Statutes, is 6 7 amended to read as follows: 8 "[+]§196-1.5 Priority permitting process for renewable 9 energy and net zero energy building projects.[+] All agencies 10 shall provide priority handling and processing for all state permits required for renewable energy and net zero energy 11 12 building projects[-]; provided that agencies shall provide priority handling and processing for net zero energy building 13 projects if the permit applications are accompanied by a 14 certificate from an architect or mechanical engineer, licensed 15 16 in the State, verifying that the project is a net zero energy 17 building. For purposes of this section, "agencies" means any 18 19 executive department, independent commission, board, bureau, office, or other establishment of the State, or any quasi-public 20

institution that is supported in whole or in part by state

- 1 SECTION 6. Section 196-2, Hawaii Revised Statutes, is
- 2 amended by adding a new definition to be appropriately inserted
- 3 and to read as follows:
- 4 ""Net zero energy building" means a residential or
- 5 commercial building that is thirty-five per cent more energy
- 6 efficient than required under the 2006 International Energy
- 7 Conservation Code, as published by the International Code
- 8 Council. This efficiency may be met by either performance-based
- 9 or prescriptive-based design."
- 10 SECTION 7. Statutory material to be repealed is bracketed
- 11 and stricken. New statutory material is underscored.
- 12 SECTION 8. This Act shall take effect upon its approval.
