### A BILL FOR AN ACT

RELATING TO EDUCATION.

### **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. The legislature finds that Hawaii's education 2 system would benefit from certain statewide standards and 3 assessments regarding teaching materials, which would allow the 4 State to be competitive for grants such as the federal Race to 5 the Top Program. The legislature also finds that setting standards and assessments for statewide curriculum may improve 6 7 the State's ability to provide a quality education to students 8 from military families who are transitioning to public schools 9 in Hawaii.

10 The purpose of this Act is to:

11 (1) Require department of education teaching materials to 12 be consistent with the federal government's Race to 13 the Top fund selection criteria for standards and 14 assessments;

15 (2) Require standards-based curriculum teaching materials
16 to be consistent with the federal government's Race to
17 the Top fund selection criteria for standards and
