## A BILL FOR AN ACT

RELATING TO EDUCATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the board of
2	education requires students to take a modern history of Hawaii
3	course to partially satisfy the social studies requirement for
4	graduation from Hawaii high schools. The board of education
5	leaves it to the discretion of school principals to award
6	waivers to allow out-of-state transfer students, including
7	military transfer students, to substitute a state history course
8	that the student has already taken for the modern history of
9	Hawaii course. The legislature finds that school principals
10	should allow out-of-state transfer students to make this
11	substitution upon request by the student, especially if failure
12	to satisfy this particular requirement makes it more difficult
13	for out-of-state transfer students to obtain the board of
14	education recognition diploma in comparison to non-transfer
15	students.

- 10 students, board of education recognition diploma eligibility.
- 11 School principals shall waive the modern history of Hawaii
- 12 requirement upon request by an out-of-state transfer student,
- 13 including a military transfer student, who has taken and passed
- 14 a different state history course that the board has approved to
- 15 satisfy that portion of the social studies high school
- 16 graduation requirement. If the student's waiver request is
- 17 approved by the appropriate school principal, that student shall
- 18 be eligible to receive the board of education recognition
- 19 diploma; provided that the student meets all other criteria, as
- 20 determined by the board, to receive the board of education
- 21 recognition diploma."
- 22 SECTION 3. New statutory material is underscored.
