RELATING TO THE WIRELESS ENHANCED 911 FUND.

1	SECTION 1.	Section 138-6,	Hawaii Revised	Statutes,	is
2	amended to read	l as follows:

4	submit an annual report to the legislature, including:
5	(1) The total aggregate surcharge collected by the State
6	in the last fiscal year;
7	(2) The amount of disbursement from the fund;
8	(3) The recipient of each disbursement and a description
9	of the project for which the money was disbursed;
10	(4) The conditions, if any, placed by the board on
11	disbursements from the fund;
12	(5) The planned expenditures from the fund in the next
13	fiscal year;
14	(6) The amount of any unexpended funds carried forward for
15	the next fiscal year;

7	this Act shall be conducted before the end of the 2010 calendar
8	year and its results shall be included in the wireless enhanced
9	911 board's report to the 2011 legislature.

11	and stricken. New statutory material is underscored.
