A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature recognizes that supporting 2 public education is a core responsibility and fundamental 3 priority of state government. In recent years, progress has 4 been made in improving educational test scores and significant 5 resources invested in supporting, rewarding, and retaining 6 quality teachers. If the State of Hawaii is to continue moving 7 forward in improving student achievement, the legislature 8 believes that instructional school days available for student 9 learning must be strengthened and not diminished. The legislature further believes that the current effort to balance 10 11 the state budget by reducing the number of instructional days is 12 counter-productive, harmful to our State on many levels, and 13 must immediately be reversed.

According to a recent statement by the United States Secretary of Education: "Now more than ever, we need to invest in schools so we can educate our way to a better economy Hawaii has been making progress on student achievement. Over

1 the 20 years that the National Assessment of Educational
2 Progress has been given to states, Hawaii students have recorded
3 steady gains But now is not the time to decrease investment
4 in education. Hawaii's economic problems should not be creating
5 an educational crisis for its children."

6 While there will be exceptions, the elimination of 7 instructional days will result in a general decline in student 8 achievement and a lowering of over-all test scores system wide. 9 As teachers adjust to the reduced number of teaching days, important subjects such as music, art, and physical fitness are 10 11 likely to be further reduced and opportunities to participate in 12 traditional after school extracurricular activities such as 13 band, clubs, and others will also dwindle as the time available is shrunk. College bound students will also be impacted as 14 15 students seeking to excel in specialized academic areas will 16 have a reduced availability of instructional time. College 17 admissions opportunities for Hawaii students in general may 18 further suffer from the increasingly poor national reputation 19 and stigma gained from having the fewest number of instructional 20 days in the nation.

21 In addition to the loss of educational opportunity for22 Hawaii's children, the "furlough Fridays" that will result in

1 the elimination of up to seventeen instructional school days a 2 year will result in a host of other unanticipated problems. In 3 testimony submitted by parents and community members before a 4 special legislative committee, it has been made very clear that 5 "furlough Fridays" will cause serious economic hardship. Many 6 families cannot afford the extra cost of child care during the 7 day or after school hours supervision. As a result, many 8 parents are now forced to take unpaid leave from work to care 9 for their school age children, while others may have no option 10 but to leave younger children in the care of older siblings, 11 friends, or neighbors.

12 Moreover, testimony from social workers and others pointed 13 out the potential for harm as large numbers of students suddenly 14 become unsupervised "latch-key children." This unstable situation may contribute to an increase in teen pregnancies, 15 16 drug use, and other detrimental activities often associated with 17 unsupervised youths. Furthermore, for some low-income families, 18 the school venue provides the primary source of positive adult 19 role models and a generally safe haven within which their 20 children may interact with adults and their peers. Public 21 testimony and various civil actions currently pending in the



1 courts also describe the potentially broad and far-reaching 2 negative impact of "furlough Fridays" on special needs children. 3 The legislature finds that closing public schools on 4 instructional school days and the lasting harm that this will 5 cause under the "furlough Fridays" arrangement is unacceptable. 6 At the same time, the legislature recognizes that, while urgent 7 and immediate action is vital to remedy the loss of any further 8 instructional school days for the 2009-2010 and 2010-2011 school 9 years, long-term solutions will require extensive review of both 10 funding and governance issues during the upcoming 2010 regular 11 legislative session.

12 The purpose of this Act is to authorize the transfer of 13 moneys from the Hawaii hurricane reserve trust fund to the department of education in order to prevent the further loss of 14 15 instructional school days for the remaining 2009-2010 and 2010-16 2011 school years. Furthermore, this Act prohibits the release 17 of funds until the existing collective bargaining agreements 18 between the department of education and the exclusive representatives of the employees of the department of education 19 20 include terms of agreement that ensure no loss of instructional 21 school days for the remaining 2009-2010 and 2010-2011 school 22 years.

1 The Hawaii hurricane reserve trust fund is SECTION 2. 2 authorized to transfer a sum in the amount of \$80,000,000 to the 3 department of education prior to January 1, 2010; provided that 4 no moneys shall be released from the Hawaii hurricane reserve 5 trust fund to the department of education until the existing collective bargaining agreements between the department of 6 7 education and the exclusive representatives of the employees of the department of education include terms of agreement that 8 9 ensure no loss of instructional school days for the remaining 10 2009-2010 and 2010-2011 school years. 11 SECTION 3. Section 431P-16, Hawaii Revised Statutes, is 12 amended by amending subsection (i) to read as follows: 13 "(i) Moneys in the hurricane reserve trust fund may be: 14 (1) Disbursed upon dissolution of the Hawaii hurricane 15 relief fund; provided that: 16 The net moneys in the hurricane reserve trust (A) **17** fund shall revert to the state general fund after 18 payments by the fund on behalf of licensed 19 property and casualty insurers or the State that 20 are required to be made pursuant to any federal 21 disaster insurance program enacted to provide
