A BILL FOR AN ACT

RELATING TO THE LICENSING OF ARCHAEOLOGISTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that it is the public
policy of the State of Hawaii to protect significant
archaeological and burial sites.

The practice of archaeology is often affected and driven by development needs. Accordingly, the practice of archaeology should be subject to regulation and control to ensure the public that standards to preserve and protect archaeological sites are being met.

The legislature further finds that the practice of 9 archaeology is dynamic and continues to evolve with more 10 11 sophisticated techniques and the incorporation of knowledge from past work in the field. Additionally, the public is 12 increasingly interested in the archaeology and history of the 13 places that they live in. As the bridge between the past and 14 present, archaeologists have both a public and private duty to 15 ensure that significant archaeological and burial sites are 16 protected. 17

5	SECTION 2. The Hawaii Revised Statutes is amended by
6	adding to title 25 a new chapter to be appropriately designated
7	and to read as follows:

10	§ -1 Definitions. For the purposes of this chapter:
11	"Archaeologist" means a person who shall have the following
12	professional qualifications to practice archaeology in Hawaii:
13	(1) A graduate degree from an accredited institution in
14	archaeology, or anthropology, with a specialization in
15	archaeology, or an equivalent field;
16	(2) At least one year of cumulative archaeological
17	experience in Hawaii or the Pacific;
18	(3) At least four months of supervised archaeological
19	field and analytic experience in Hawaii;
20	(4) At least one year of archaeological research,
21	administration, or management at a supervisory level
22	with at least four months of field experience;

1	(5) A demonstrated ability to carry research to
2	completion, as shown by completed theses,
3	publications, and manuscripts; and
4	(6) A demonstrated knowledge of historic preservation
5	laws, rules, and guidelines.
6	"Department" means the department of commerce and consumer
7	affairs.
8	"Director" means the director of commerce and consumer
9	affairs.
10	§ -2 Limitations. Nothing in this chapter shall
11	override the requirements of chapter 6E or any rules adopted
12	thereunder.
13	§ -3 License required. No person shall use the title
14	"archaeologist" or like title, or serve as principal
15	investigator on an archaeological study permitted by the State
16	of Hawaii unless licensed as an archaeologist under this
17	chapter.
18	§ -4 Powers and duties of the director. In addition to
19	any other powers and duties authorized by law, the director
20	shall:
21	(1) Adopt rules pursuant to chapter 91 to develop
22	standards for licensure;

PURPOSE:

A BILL FOR AN ACT RELATING TO THE LICENSING OF ARCHAEOLOGISTS.

To regulate the practice of archaeology by authorizing the Director of the Department of Commerce and Consumer Affairs (DCCA) to establish licensure requirements for and regulate archaeologists.

MEANS:

Add a new chapter to title 25, Hawaii Revised Statutes (HRS).

JUSTIFICATION:

The practice of archaeology is often affected and driven by development needs. Accordingly, the practice of archaeology should be subject to regulation and control to ensure the public that standards to preserve and protect archaeological sites are being met.

Further, the practice of archaeology is dynamic and continues to evolve with more sophisticated techniques and the incorporation of knowledge from past work in the field. Additionally, the public is increasingly interested in the archaeology and history of the places that they live in. As the bridge between the past and present, archaeologists have both a public and private duty to ensure that significant archaeological and burial sites are protected.

This bill would authorize the Director of DCCA to establish licensure requirements for and regulate archaeologists in the State of Hawaii.

Impact on the public: Archaeological research in the State would be standardized and inventory surveys could be processed in more timely fashion.

SB. NO. 2739

Impact on the department and other agencies: This bill ensures that archaeology in Hawaii is practiced at a minimum professional standard and subject to oversight, thereby meeting the important public policy purposes of chapter 6E, HRS, in preserving Hawaii's significant cultural and historical sites and structures.
