- 1 SECTION 1. Section 286-240, Hawaii Revised Statutes, is
- amended by amending subsections (g) and (h) to read as follows: 2
- "(q) The examiner of drivers shall disqualify any person 3
- from driving a commercial motor vehicle for a period of not less 4
- than [ninety] one hundred eighty days and not more than one year 5
- for a first violation, or for at least [one year] two years and 6
- not more than five years for a second violation, or at least 7
- three years and not more than five years for a third or 8
- subsequent violation of a driver or vehicle out-of-service order 9
- committed in a commercial motor vehicle transporting non-10
- hazardous materials arising from separate incidents occurring 11
- within a ten-year period. 12
- The examiner of drivers shall disqualify any person (h) 13
- from driving a commercial motor vehicle for a period of not less 14
- than one hundred eighty days [or] and not more than two years 15
- for a first violation, or for at least three years and not more 16
- than five years for any subsequent violation, of a driver or 17
- vehicle out-of-service order committed in a commercial motor 18

JUSTIFICATION:

The intent of the proposed change is to meet the requirements of 49 C.F.R. section

383.51(e) before September 4, 2010, as required by Safe, Accountable, Flexible, Efficient Transportation Equity Act: A

Legacy for Users (SAFETEA-LU).

Failure to enact the changes required in the Federal Motor Carrier Safety Administration (FMCSA) regulation could result in the loss of approximately \$4,600,000 (or 5 percent) of federal-aid highway funds (based on fiscal year 2007-2008 funding) for the first year of noncompliance and \$9,300,000 (or 10 percent) per year thereafter. Motor Carrier Safety Assistance Program (MCSAP) grant funds (\$660,667 in fiscal year 2007-2008) could also be withheld for each year of

noncompliance.
