#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 286-207, Hawaii Revised Statutes, is
 amended to read as follows:

#### JUSTIFICATION SHEET

DEPARTMENT:

Transportation

TITLE:

A BILL FOR AN ACT RELATING TO SAFETY INSPECTION OF MOTOR CARRIER VEHICLES.

PURPOSE:

Conform sections 286-207 and 286-209, Hawaii Revised Statutes, to be compatible with the Federal Motor Carrier Safety Regulations (FMCSR).

MEANS:

Amend sections 286-207 and 286-209, Hawaii Revised Statutes.

JUSTIFICATION:

Presently, the State Department of Transportation's Motor Vehicle Safety Office (MVSO) receives federal moneys from the Federal Motor Carrier Safety Administration (FMCSA) to fund its Motor Carrier Safety Assistance Program (MCSAP) and New Entrant Incentive Program. This funding allows the State Motor Carrier Officers to enforce the Federal Motor Carrier Safety Regulations and the Hazardous Material Regulations that ultimately provide safer roads for our residents and visitors.

The 2003 Program Review and the 2007 Program Review done by the FMCSA found that sections 286-207 and 286-209 were incompatible with the FMCSR. Section 350.341 reads in pertinent part, "However, a State may not exempt a CMV (Commercial Motor Vehicle) from such laws or regulations if the vehicle: (1) Transports hazardous materials requiring a placard." Nevertheless, this issue was not addressed in previous legislative sessions.

However, this issue must be addressed this legislative session to avoid any type of sanctions levied by the FMCSA. Section 350.335(d) reads, "Upon a finding by the FMCSA, based upon its own initiative or upon a petition of any person, including any

State, that your State law, regulation or enforcement practice pertaining to CMV safety, in either interstate or intrastate commerce, is incompatible with the FMCSRs or HMRs, the FMCSA may initiate a proceeding under §350.215 for withdrawal of eligibility for all Basic Program and Incentive Funds."

Impact on the public: If funding provided by the FMCSA is "withdrawn" because the state statute is incompatible with the FMCSR or Hazardous Materials Regulations (HMR), the state would have to replenish the withdrawn FMCSA funding to continue to enforce the state motor carrier safety laws to ensure compliance by the commercial motor carriers and to ensure that the roads in the State of Hawaii are safe for the traveling public.

Impact on the department and other agencies: There would be a loss of FMCSA funding necessary for the state motor carrier officers to continue to enforce the federal regulations as it relates to commercial motor vehicles.
