### A BILL FOR AN ACT

RELATING TO THE REGENTS CANDIDATE ADVISORY COUNCIL.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 304A-104.5, Hawaii Revised Statutes, is amended as follows:

3 1. By amending subsection (d) to read:

4 "(d) In making its presentations, the regents candidate 5 advisory council shall:

6 (1) Develop a statement that includes the selection
7 criteria to be applied and a description of the
8 responsibilities and duties of a member of the board
9 of regents and distribute this statement to potential
10 candidates;

11 (2) Screen and qualify candidates for each position on the
12 board of regents based on their background,
13 experience, and potential for discharging the
14 responsibilities of a member of the board of regents;
15 (3) Publicly advertise pending vacancies and actively

1 sitting members on the regents candidate advisory council shall 2 make an interim appointment to fill the vacant seat. The 3 interim appointee shall satisfy the requirements for appointment 4 provided in this subsection and shall serve until the time when 5 the appropriate appointing authority makes an appointment for 6 the vacant seat as provided in this subsection. Appointees to 7 the regents candidate advisory council shall have a general 8 understanding of the purposes of higher education, the mission 9 of the University of Hawaii system, and the responsibilities of 10 the board of regents. Appointees shall be individuals who are 11 widely viewed as having placed the broad public interest ahead 12 of special interests, having achieved a high level of prominence in their respective professions, and being respected members of 13 14 the community."

15 SECTION 2. Statutory material to be repealed is bracketed 16 and stricken. New statutory material is underscored.

17 SECTION 3. This Act shall take effect upon its approval.

#### Report Title:

University of Hawaii; Regents Candidate Advisory Council

#### Description:

Establishes a working group within the University of Hawaii board of regents candidate advisory council to ensure student involvement in recruitment and evaluation of student member candidates. Makes ineligible for appointment to the candidate advisory council an individual who has served on the all campus council of faculty senate chairs within the last five years immediately preceding that appointment or on the executive council of the University of Hawaii student caucus within one year immediately preceding that appointment.
