## A BILL FOR AN ACT

RELATING TO CLEAN AND SOBER AND HALFWAY HOME REGULATION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that clean and sober SECTION 1. 2 homes and halfway houses provide a means for persons to return 3 to the community through support in a less structured home-like 4 environment but without the structure of a therapeutic care facility or therapeutic living program. Persons being released 5 from incarceration in locked jail or prison facilities 6 especially need the support of a home environment while trying 7 8 to deal with the stressors of reintegrating back into society 9 while maintaining sobriety. The legislature also finds that there is a community concern regarding having such homes in 10 their immediate vicinity, and their concerns must be tempered 11 12 with the needs of the individuals requiring support.

13 The purpose of this Act is to establish a task force to 14 determine how best to balance the interests of all parties 15 involved, to define what a clean and sober home and halfway home 16 is, and how to most effectively require accountability from

5 The department of health shall be the chair of the task force 6 and shall convene and oversee its activities. The task force 7 shall report to the legislature on the scope and nature of the 8 accountability plan for the clean and sober and halfway houses, 9 the process by which the houses will be monitored, the way in 10 which concerns of community members are balanced with concerns 11 of those requiring the support of the homes, and how the homes 12 will be regulated short of direct governmental oversight.

13 SECTION 4. The task force shall submit to the legislature 14 no later than twenty days prior to the convening of the regular 15 session of 2011, a report on the recommendations of the task 16 force and any proposed legislation that may be necessary to 17 effectuate those recommendations.

18 SECTION 5. This Act shall take effect upon its approval.
