# A BILL FOR AN ACT

PROPOSING AN AMENDMENT TO ARTICLE VII, SECTION 6, OF THE HAWAII CONSTITUTION, RELATING TO THE TAX REBATE REQUIREMENT.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The purpose of this Act is to propose an
2	amendment to article VII, section 6, of the Hawaii Constitution
3	to amend the requirement that excess general fund revenues be
4	returned to taxpayers of the State as a tax refund or tax credit
5	and allow the legislature to deposit these excess revenues into
6	one or more emergency and budget reserve funds as an
7	alternative.
8	SECTION 2. Article VII, section 6, of the Hawaii
9	Constitution is amended to read as follows:
10	"DISPOSITION OF EXCESS REVENUES
11	Section 6. Whenever the state general fund balance at the
12	close of each of two successive fiscal years exceeds five
13	percent of general fund revenues for each of the two fiscal
14	years, the legislature in the next regular session shall provide
15	for a tax refund or tax credit to the taxpayers of the State, <u>or</u>
16	make a deposit into one or more emergency and budget reserve
17	funds, as provided by law."

1 SECTION 3. The question printed on the ballot shall be as 2 follows: 3 "Shall the legislature be provided with the choice, when 4 the state general fund balance at the close of each of two 5 successive fiscal years exceeds five per cent of the 6 general fund revenues for each of the two fiscal years, to provide a tax refund or tax credit to the taxpayers of the 7 8 State, or to make a deposit into one or more emergency and 9 budget reserve funds?" 10 SECTION 4. New constitutional material is underscored. 11 SECTION 5. This amendment shall take effect upon 12 compliance with article XVII, section 3, of the Hawaii 13 Constitution.
