## A BILL FOR AN ACT

RELATING TO PHARMACIES.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Chapter 461, Hawaii Revised Statutes, is
amended by adding a new section to be appropriately designated
and to read as follows:
"§461- Electronic prescriptions; capacity required. (a)
Every pharmacy and remote dispensing pharmacy operating under a
permit or prior notification issued pursuant to this chapter
shall have the capacity to maintain prescription records
electronically and to accept and transmit prescription
information electronically or by facsimile in accordance with
the requirements of sections 328-17.7 and 328-17.8."
SECTION 2. Section 328-17.7, Hawaii Revised Statutes, is
amended to read as follows:
"\$328-17.7 Record of prescriptions. (a) Every
practitioner, pharmacist, or medical oxygen distributor who
compounds, sells, or delivers any prescribed drug to a patient
or a patient's agent shall maintain records that identify:

- 3 SECTION 3. Each pharmacy and remote dispensing pharmacy
- 4 subject to chapter 461, Hawaii Revised Statutes, shall be in
- 5 compliance with this Act by no later than January 1, 2012.
- 6 Failure to comply with this Act shall constitute a violation of
- 7 chapter 461, Hawaii Revised Statutes, subject to disciplinary
- 8 action imposed by the board of pharmacy pursuant to section 461-
- 9 21, Hawaii Revised Statutes.
- 10 SECTION 4. Statutory material to be repealed is bracketed
- 11 and stricken. New statutory material is underscored.
- 12 SECTION 5. This Act shall take effect on July 1, 2050.
