A BILL FOR AN ACT

RELATING TO CRIME.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 286-124, Hawaii Revised Statutes, is 2 amended to read as follows: 3 "§286-124 Mandatory revocation of license by a court. 4 Any court of competent jurisdiction shall forthwith revoke 5 permanently and without possibility of reinstatement, the 6 license, of any driver upon a conviction of the driver of 7 manslaughter resulting from the operation of a motor vehicle. 8 (b) Any court of competent jurisdiction shall forthwith 9 revoke the license of any driver for a period not less than five years but not more than ten years upon conviction of the driver 10 11 of negligent homicide in the first degree under section 707-12 702.5, in addition to any other applicable penalty." 13 SECTION 2. Section 706-624, Hawaii Revised Statutes, is 14 amended by amending subsection (2) to read as follows: 15 Discretionary conditions. The court may provide, as 16 further conditions of a sentence of probation, to the extent

that the conditions are reasonably related to the factors set

- 1 forth in section 706-606 and to the extent that the conditions
- 2 involve only deprivations of liberty or property as are
- 3 reasonably necessary for the purposes indicated in section 706-
- 4 606(2), that the defendant:
- 5 (a) Serve a term of imprisonment not exceeding two years
- 6 in class A felony cases under part IV of chapter
- 7 712[τ] or in a conviction under section 707-702,
- 8 eighteen months in class B felony cases, one year in
- 9 class C felony cases, six months in misdemeanor cases,
- 10 and five days in petty misdemeanor cases; provided
- 11 that notwithstanding any other provision of law, any
- order of imprisonment under this subsection that
- 13 provides for prison work release shall require the
- 14 defendant to pay thirty per cent of the defendant's
- gross pay earned during the prison work release period
- 16 to satisfy any restitution order. The payment shall
- 17 be handled by the adult probation division and shall
- 18 be paid to the victim on a monthly basis;
- 19 (b) Perform a specified number of hours of services to the
- community as described in section 706-605(1)(d);
- 21 (c) Support the defendant's dependents and meet other
- family responsibilities;

14		including but not limited to the victim of the crime,
15		any witnesses, regardless of whether they actually
16		testified in the prosecution, law enforcement

18		whom contact may adversely affect the rehabilitation
19		or reformation of the person convicted;
20	(h)	Refrain from use of alcohol or any use of narcotic
21		drugs or controlled substances without a prescription
