A BILL FOR AN ACT

RELATING TO ADULT AND COMMUNITY EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to transfer the
- 2 adult and community education program from the department of
- 3 education to the University of Hawaii community colleges.
- 4 SECTION 2. Chapter 304A, part IV, Hawaii Revised Statutes,
- 5 is amended by adding four new sections to be appropriately
- 6 designated and to read as follows:
- 7 "§304A-A Adult and community education authorized. To
- 8 provide increased opportunity for the people of Hawaii, the
- 9 board of regents shall establish and regulate in the community
- 10 colleges a program of adult and community education of less than
- 11 college grade. The board of regents shall provide community
- 12 college buildings and other facilities, and use community
- 13 college equipment under conditions determined by the board, when
- 14 the equipment is needed, for adult and community education
- programs.
- 16 §304A-B Scope of adult and community education programs
- 17 offered. As rapidly as resources are available and interest is

1	developed	, instructional programs shall be initiated in the
2	following	fields:
3	(1)	Basic elementary education. A foundation program in
4		reading and speaking English, writing, and arithmetic
5		for persons with no schooling or only primary grade
6		training;
7	(2)	Advanced elementary education. A program in advanced
8		elementary education for those persons who have
9		completed four to eight years of schooling and who
10		desire to obtain more complete mastery of the
11		fundamentals;
12	(3)	Secondary education. A program of secondary education
13		for those adults who, in youth, left school or for
14		some reason had their education curtailed and who now
15		desire to continue their education; for those youths
16		who have been excepted from compulsory attendance
17		under section 302A-1132; and for those youths who are
18		in need of courses to complete their high school
19		graduation requirements;
20	(4)	Adult literacy education. A basic program in reading
21		and writing English, and arithmetic for persons who
22		need to develop or improve their mastery of basic

1		literacy skills in these areas for purposes of
2		enhancing their personal, social, or employment lives;
3	(5)	Homemaking and parent education. A program in
4		homemaking and parent education for all those parents
5		and other adults who desire training in family life,
6		including child care, nursing, budgeting, and other
7		instruction basic to homemaking;
8	(6)	Community education. A program to facilitate
9		understanding and enlightenment in civic duties,
10		responsibilities, and obligations for all persons who
11		desire to keep pace with today's community, national,
12		and world developments and who realize the necessity
13		of continuing study for the adequate fulfillment of
14		their civic functions. Community education addresses
15		responsibilities within a given community, especially
16		concerns related to education and the schools, and
17		offers additional services to supplement and enrich
18		the educational program of in-school children and
19		youths;
20	(7)	Naturalization training. The standard course of
21		training provided by the United States Citizenship and
22		Immigration Services, which shall be provided to all

1		those persons who have filed applications for United
2		States citizenship and desire to enroll in such a
3		course under the supervision of the advisory council
4		established under section 304A-C; and
5	(8)	Cultural opportunities. A program of adult and
6		community education that will meet the interests and
7		desires of those people who wish to enrich and to
8		broaden their cultural, recreational, and social
9		interests."
0	<u>§</u> 304	A-C Advisory council for adult and community
1	education	. The board of regents shall appoint an advisory
12	council f	or adult and community education composed of fifteen or
13	more repr	esentatives of industry, labor, civic organizations,
14	and educa	tion. Appointments shall be for a term of two years
15	with reap	pointments optional but not to exceed a total of six
16	years on	the advisory council.
17	<u>§304</u>	A-D Financing adult and community education program.
18	The finan	cial support for this program shall be in part from
19	fees coll	ected from students enrolled, and in part from public
20	funds app	propriated for this purpose. Fees shall be set in
21	accordanc	e with the recommendations of the advisory council, and

1	may be co	llected from students regularly enrolled; provided
2	that:	
3	(1)	Adults registered with the department of labor and
4		industrial relations and unemployed shall be granted
5		free enrollment in such courses as will tend to assist
6		these persons in securing employment;
7	(2)	Adults certified by the department of human services
8		as indigent may be enrolled on a nonfee basis in
9		classes that will tend to assist these persons in
10		becoming self-sustaining;
11	(3)	Discharged veterans who are entitled to federal
12		educational assistance shall be enrolled upon
13		authorization of the Department of Veterans Affairs
14		and fees shall be charged against federal funds in
15		accordance with Department of Veterans Affairs
16		contract regulations; and
17	(4)	Administrative and supervisory costs, costs of
18		instruction, and all other necessary expenses not
19		covered by fees and other authorized charges shall be
20		paid for out of funds appropriated for this purpose."
21	SECT	ION 3. Sections 302A-432 through 302A-435, Hawaii
22	Revised S	tatutes, are repealed.

1	[" [§302A-432] Adult and community education authorized.
2	To provide increased opportunity for the people of Hawaii, the

5	[§302A-435] Financing adult and community education
6	program. The financial support for this program shall be in
7	part from fees collected from students enrolled, and in part
8	from public funds appropriated for this purpose. Fees shall be
9	set in accordance with the recommendations of the advisory
10	council, and may be collected from students regularly enrolled;
11	provided that:
12	(1) Adults registered with the department of labor and
13	industrial relations and unemployed shall be granted
14	free enrollment in such courses as will tend to assist
15	these persons in securing employment;
16	(2) Adults certified by the department of human services
17	as indigent may be enrolled on a nonfee basis in
18	classes that will tend to assist these persons in
19	becoming self sustaining;
20	(3) Discharged veterans who are entitled to federal
21	educational assistance shall be enrolled upon
22	authorization of the Department of Veterans Affairs

1	and fees shall be charged against federal funds in

8	SECTION 4. In codifying the new sections added by section
9	2 of this Act, the revisor of statutes shall substitute
10	appropriate section numbers for the letters used in designating
11	the new sections in this Act.
12	SECTION 5. All rights, powers, functions, and duties of
13	the adult and community education program are transferred to the
14	University of Hawaii community colleges.
15	All officers and employees whose functions are transferred
16	by this Act shall be transferred with their functions and shall
17	continue to perform their regular duties upon their transfer,
18	subject to the state personnel laws and this Act.
19	No officer or employee of the State having tenure shall
20	suffer any loss of salary, seniority, prior service credit,
21	vacation, sick leave, or other employee benefit or privilege as
22	a consequence of this Act, and such officer or employee may be

- 1 transferred or appointed to a civil service position without the
- 2 necessity of examination; provided that the officer or employee
- 3 possesses the minimum qualifications for the position to which
- 4 transferred or appointed; and provided that subsequent changes
- 5 in status may be made pursuant to applicable civil service and
- 6 compensation laws.
- 7 An officer or employee of the State who does not have
- 8 tenure and who may be transferred or appointed to a civil
- 9 service position as a consequence of this Act shall become a
- 10 civil service employee without the loss of salary, seniority,
- 11 prior service credit, vacation, sick leave, or other employee
- 12 benefits or privileges and without the necessity of examination;
- 13 provided that such officer or employee possesses the minimum
- 14 qualifications for the position to which transferred or
- 15 appointed.
- 16 If an office or position held by an officer or employee
- 17 having tenure is abolished, the officer or employee shall not
- 18 thereby be separated from public employment, but shall remain in
- 19 the employment of the State with the same pay and classification
- 20 and shall be transferred to some other office or position for
- 21 which the officer or employee is eligible under the personnel

- 1 laws of the State as determined by the head of the department or
- 2 the governor.
- 3 SECTION 6. All appropriations, records, equipment,
- 4 machines, files, supplies, contracts, books, papers, documents,
- 5 maps, and other personal property heretofore made, used,
- 6 acquired, or held by the department of education relating to the
- 7 functions transferred to the University of Hawaii community
- 8 colleges shall be transferred with the functions to which they
- 9 relate.
- 10 SECTION 7. This Act does not affect rights and duties that
- 11 matured, penalties that were incurred, and proceedings that were
- 12 begun before its effective date.
- 13 SECTION 8. Statutory material to be repealed is bracketed
- 14 and stricken. New statutory material is underscored.
- 15 SECTION 9. This Act shall take effect on July 1, 2010.
