## A BILL FOR AN ACT

RELATING TO FLAGS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that more than 500,000 2 Americans have been captured and interned as prisoners of war
- $oldsymbol{3}$  since the American Revolution. The largest number of prisoners
- 4 held captive occurred during the Civil War when an estimated
- 5 220,000 confederate soldiers were captured by the North and
- 6 nearly 127,000 union soldiers were interned by the South.
- 7 Since World War I, over 142,000 Americans, including
- $oldsymbol{8}$  eighty-five women, have been captured and interned as prisoners
- ${f 9}$  of war. Not included in this figure are nearly 93,000 Americans
- 10 who are classified as missing in action.
- 11 The legislature also finds that, as our country seeks out
- 12 Al Qaeda terrorists in the middle east, it is important to
- 13 recognize and honor the extraordinary heroism of the brave men
- 14 and women who risked or sacrificed their lives or their freedom
- 15 in the past, as well those who place their lives in harm's way
- 16 on a daily basis in Afghanistan and Iraq.
- 17 The purpose of this Act is to require the National League

- 1 with the United States and Hawaiian flags to honor American 2 prisoners of war and military personnel who are missing in 3 action. SECTION 2. Chapter 5, Hawaii Revised Statutes, is amended 4 5 by adding a new section to be appropriately designated and to 6 read as follows: 7 Prisoner of war/missing in action flag; 8 recognition; use. (a) The State recognizes the National League 9 of Families' Prisoner of War/Missing in Action flag that was **10** recognized by the United States Congress through Pub. L. 101-355 11 on August 10, 1990. 12 If a building is under the jurisdiction of the State, 13 including the state department of defense state headquarters 14 building, and the Hawaiian flag is flown under the same or a 15 separate halyard as the flag of the United States of America, 16 the prisoner of war/missing in action flag shall be flown under 17 the flag of the United States of America. 18 This section shall not apply: (c) 19 To public schools under chapter 302A; and (1)20 (2) Halyards that do not fly any flags due to safety or 21 community concerns."
  - SECTION 3. New statutory material is underscored.
