A BILL FOR AN ACT

RELATING TO FLAGS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that more than five 2 hundred thousand Americans have been captured and interned as 3 prisoners of war since the American Revolution. The largest 4 number of prisoners held captive occurred during the Civil War 5 when an estimated two hundred twenty thousand confederate 6 soldiers were captured by the North and nearly one hundred 7 twenty-seven thousand union soldiers were interned by the South. 8 Since World War I, over one hundred forty-two thousand 9 Americans, including eighty-five women, have been captured and 10 interned as prisoners of war. Not included in this figure are 11 nearly ninety-three thousand Americans who are classified as

12 missing in action.

13 The legislature also finds that, as our country seeks out 14 Al Qaeda terrorists in the Middle East, it is important to 15 recognize and honor the extraordinary heroism of the brave men 16 and women who risked or sacrificed their lives or their freedom 17 in the past, as well as those who place their lives in harm's





way on a daily basis in the present, such as in Afghanistan and
Iraq.

3 The legislature further acknowledges that Hawaii is home to 4 the United States (U.S.) Pacific Command, the front line of 5 defense for the Asia-Pacific region. Few states, and perhaps no 6 other state can claim that it is supported by four component 7 commands: U.S. Pacific Fleet, U.S. Pacific Air Forces, U.S. 8 Army Pacific, and U.S. Marine Forces Pacific. These commands 9 are headquartered in Hawaii and have forces stationed and 10 deployed throughout the region that spans the waters off the west coast of the U.S. to the western border of India, and from 11 12 Antarctica to the North Pole.

13 The purpose of this Act is to require the National League 14 of Families' POW/MIA flag to be flown with the U.S. and Hawaiian 15 flags at the Hawaii capitol and at state department of defense 16 buildings to honor American prisoners of war and military 17 personnel who are missing in action.

18 SECTION 2. Chapter 5, Hawaii Revised Statutes, is amended 19 by adding a new section to be appropriately designated and to 20 read as follows:

21"§5-POW/MIA (Prisoner of war/missing in action) flag;22recognition; use.(a) The State acknowledges the National

13	(5) National POW/MIA Recognition Day, the third Friday in
14	September; and
15	(6) Veterans Day, November 11.
16	(c) On any day other than those specified under subsection
17	(b), the POW/MIA flag may be flown at the Hawaii capitol and
18	state department of defense buildings."
19	SECTION 3. New statutory material is underscored.
20	SECTION 4. This Act shall take effect on July 1, 2040.
