A BILL FOR AN ACT

RELATING TO STATE ENTERPRISE ZONES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that adding businesses 2 engaged in the development or production of various types of renewable energy to the state enterprise zone program will 3 4 stimulate business, agricultural, and industrial growth. The 5 legislature further finds that adding other forms of renewable resources including sun, falling water, biogas, geothermal, 6 7 ocean water, currents and waves, biomass, biofuels, and hydrogen 8 production from renewable energy sources into the state 9 enterprise zone program is consistent with currently approved 10 business activities, which include wind energy production. This 11 Act will provide the impetus to help attract renewable energy 12 businesses to Hawaii and further the State's renewable energy 13 goals.

14 The purpose of this Act is to expand eligible business 15 activity in the state enterprise zones to include the 16 development or production of various types of renewable energy.

12		which were grown within an enterprise zone;	
13	(3)	Research, development, sale, or production of all	
14		types of genetically-engineered medical, agricultural,	
15		or maritime biotechnology products; or	
16	(4)	[Production of electric power from wind energy for	
17		sale primarily to a public utility company for resale	
18		to the public.] Development or production of fuels,	
19		thermal energy, or electrical energy from renewable	
20		resources, including:
