A BILL FOR AN ACT

RELATING TO THE HAWAIIAN LANGUAGE COLLEGE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The Hawaiian language college at the University
2	of Hawaii at Hilo, department of education, and charter school
3	administrative office shall enter into an agreement regarding
4	the Hawaiian language college's functions related to
5	Nawahiokalani'opu'u school and other schools, as appropriate, as
6	laboratory schools, under section 304A-1302(2), Hawaii Revised
7	Statutes. The agreement shall include the following provisions:
8	(1) The department of education and the charter school
9	administrative office shall consult with the Hawaiian
10	language college in determining which service
11	functions are best provided by the Hawaiian language
12	college, rather than the standard entities of the
13	department of education and the charter school
14	administrative office, and reach agreement that the
15	Hawaiian language college shall provide specific
16	functions through the Hawaiian language, such as in-
17	service training in literacy development when Hawaiian
18	literacy development requires different strategies;

1	(2)	The Hawaiian language college, department of							
2		education, and charter school administrative office							
3		shall review annually:							
4		(A) All activities implemented under the agreement;							
5		(B) The success of implementation and any issues or							
6	,	problems to be resolved;							
7		(C) Any recommendations for changes in the agreement;							
8		and							
9		(D) Ways in which implementation under the agreement							
10		contributes to the provision of Hawaiian language							
11		medium education, pursuant to chapter 302H,							
12		Hawaii Revised Statutes;							
13	(3)	The Hawaiian language college may use its own funds,							
14		funds from external sources, special legislative							
15		appropriations, or funds that the department of							
16		education may transfer to the Hawaiian language							
17		college for the functions described in this Act;							
18	(4)	The agreement shall be required to cover only those							
19		programs and entities known by the broad name							
20		Nawahiokalani'opu'u school, with other laboratory							
21		schools to be included at the joint request of those							
22	•	schools and the Hawaiian language college; and
