## A BILL FOR AN ACT

RELATING TO THE ALOHA TOWER DEVELOPMENT CORPORATION.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

4	SECTION 2. Except as otherwise provided in this Act, all
5	rights, powers, functions, and duties of the Aloha Tower
6	development corporation are transferred to the Hawaii community
7	development authority under chapter 206E, Hawaii Revised
8	Statutes, except with respect to harbors modernization functions
9	which shall be transferred to the department of transportation.
10	SECTION 3. All appropriations, records, equipment,
11	machines, files, supplies, contracts, books, papers, documents,
12	maps, and other personal property heretofore made, used,
13	acquired, or held by the Aloha Tower development corporation
14	relating to the functions transferred to the Hawaii community
15	development authority shall be transferred with the functions to
16	which they relate.

9	July 1, 2010.

SECTION 5. Chapter 266, Hawaii Revised Statutes, is 1 amended by adding a section to be appropriately designated and 2 3 to read as follows: Harbors modernization group; commercial harbors 4 "§266− 5 modernization plan. (a) No later than July 1, 2010, the 6 harbors modernization group shall be administratively placed 7 under the department of transportation. The harbors 8 modernization group shall have jurisdiction over the harbors 9 modernization project, to undertake projects for the commercial **10** harbors modernization plan. All projects, prior to 11 implementation, shall be approved by the governor. If the **12** governor approves a project, the harbors modernization group 13 shall have expending authority over the approved project, 14 notwithstanding any law to the contrary. 15 For purposes of this subsection, the department of transportation shall seek the input and guidance of the United 16 17 States Department of Transportation Maritime Administration in 18 the management of the harbors modernization project; provided 19 that the department of transportation may enter into an 20 agreement with the United States Department of Transportation 21 Maritime Administration for the purpose of infrastructure 22 improvements of harbors statewide.
