## A BILL FOR AN ACT

RELATING TO THE ENVIRONMENT.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 343, Hawaii Revised Statutes, is 2 amended by adding a new section to be appropriately designated 3 and to read as follows: 4 Exemption; protection of native species, habitat, "§343− 5 and ecosystems. (a) Notwithstanding section 343-5(a), an 6 environmental assessment shall not be required for any action approved by the department of land and natural resources that 7 protects, preserves, or enhances native species, native habitat, 8 or native ecosystem function, including but not limited to: 9 10 (1) Invasive species control using approved methods in accordance with state and federal law; 11 12 The installation of barriers to control non-native (2) animals; and 13 14 (3) The installation of dip tanks for fire control or other related helicopter landing zones and field 15 16 camps.

1	The determination to exempt any action under this section shall
2	be made by the department of land and natural resources, through
3	the relevant division, on a case-by-case basis considering any
4	potential impacts on land and aquatic resources, cultural
5	effects, and human health and safety.
6	(b) Each party or agency proposing to qualify for an
7	exemption provided for in this section shall submit a request to
8	the department of land and natural resources, detailing the
9	proposed action and describing any potential impacts. The
10	department of land and natural resources shall publish the
11	request in the bulletin, pursuant to section 343-3; provided
12	that the request shall be published in the next available
13	bulletin and shall be available for inspection by the public and
14	for review and comments for a minimum of thirty days. Any
15	comments submitted pursuant to this subsection shall be
16	submitted to the department of land and natural resources.
17	(c) Not less than thirty days and not more than sixty days
18	after publication of the request pursuant to subsection (b), the
19	department of land and natural resources, after consideration of
20	all submitted comments, shall determine whether the proposed
21	action qualifies for the exemption provided under this section.

2	The findings and reasons for any exemption approved under this
3	section shall be available for inspection by the public upon

5	SECTION 2. This Act does not affect rights and duties that
6	matured, penalties that were incurred, and proceedings that were
7	begun before its effective date.
