A BILL FOR AN ACT

RELATING TO THE HAWAII TEACHER STANDARDS BOARD.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the thirteen-member
- 2 Hawaii teacher standards board is responsible for establishing
- 3 standards for the issuance and renewal of licenses for teachers;
- 4 serves as the final adjudicator for appeals relating to
- 5 licensing, including issuance or nonissuance of licenses, and
- 6 the suspension, nonrenewal, and revocation of licenses; and
- 7 approves teacher education programs and the professional
- 8 development of teachers.
- 9 In 2008, Senate Concurrent Resolution No. 83, S.D. 1,
- 10 requested the auditor to conduct a study on the appropriate
- 11 accountability structure for the Hawaii teacher standards board,
- 12 and to report the findings and recommendations to the 2009
- 13 legislature.
- The purpose of this Act is to respond to the auditor's
- 15 findings and recommendations by establishing an advisory
- 16 committee to provide oversight of the Hawaii teacher standards
- 17 board.



1 SECTION 2. Chapter 302A, Hawaii Revised Statutes, is 2 amended by adding a new section to be appropriately designated 3 and to read as follows: 4 "§302A- Advisory committee for the Hawaii teacher 5 standards board; established. (a) There is established the 6 advisory committee for the Hawaii teacher standards board to 7 provide oversight of the Hawaii teacher standards board. 8 advisory committee shall consist of seven members to be 9 appointed without regard to section 26-34, with one member 10 representing each of the following: 11 (1) The Hawaii P-20; 12 (2) The Hawaii Business Roundtable; 13 (3) The Society for Human Resource Management Hawaii 14 Chapter; (4)15 The workforce development council; 16 (5) The Hawaii Association of Independent Schools; 17 (6) A Hawaii recipient of the Milken Educator Award; and 18 A national board certified Hawaii teacher. (7) 19 The advisory committee shall be attached to the board of 20 education for administrative purposes. 21 The advisory committee shall review and evaluate the (b)

progress of the Hawaii teacher standards board in meeting its

- 3 (c) The advisory committee shall present to the governor
- 4 lists of qualified candidates from which the members of the
- 5 Hawaii teacher standards board shall be nominated and, by and
- 6 with the consent of the senate, appointed by the governor. The
- 7 advisory committee shall establish the criteria for qualifying,
- 8 screening, and presenting to the governor candidates for
- 9 membership on the Hawaii teacher standards board; provided that
- 10 the advisory committee shall adhere to the membership
- 11 requirements of section 302A-801.
- 12 (d) The advisory committee shall present to the board of
- 13 education a list of qualified candidates for the executive
- 14 director of the Hawaii teacher standards board and the board of
- 15 education shall appoint the executive director, pursuant to
- 16 section 302A-803.
- 17 (e) The advisory committee shall submit an annual report
- 18 to the board of education and to the legislature on the Hawaii
- 19 teacher standards board operations, including any deficiencies
- 20 in meeting the requirements of chapter 302A, part III,
- 21 subpart D."

1 SECTION 3. Section 302A-801, Hawaii Revised Statutes, is 2 amended by amending subsection (b) to read as follows: 3 Except for the chairperson of the board of education, the superintendent, and the dean of the college of education, 4 5 the governor shall appoint the members of the board pursuant to section 26-34, from a list of qualified nominees submitted to 7 the governor by the [departments, agencies, and organizations 8 representative of the constituencies of the] advisory committee 9 for the Hawaii teacher standards board. To the extent possible, 10 the board membership shall reflect representation of elementary 11 and secondary school personnel from all islands." 12 SECTION 4. Section 302A-803, Hawaii Revised Statutes, is 13 amended to read as follows: 14 "§302A-803 Powers and duties of the board. (a) In 15 addition to establishing standards for the issuance and renewal 16 of licenses and any other powers and duties authorized by law, 17 the board's powers shall also include: 18 (1) Setting and administering its own budget; 19 Adopting, amending, or repealing the rules of the (2) 20 board in accordance with chapter 91; 21 (3) Receiving grants or donations from private

foundations, and state and federal funds;

2		information to schools and operational personnel;
3	(12)	Approving teacher preparation programs;
4	(13)	Administering reciprocity agreements with other states
5		relative to licensing;
6	(14)	Conducting research and development on teacher
7		licensure systems, beginning teacher programs, the
8		assessment of teaching skills, and other related
9		topics;
10	(15)	Participating in efforts relating to teacher quality
11		issues, conducting professional development related to
12		the board's standards, and promotion of high teacher
13		standards and accomplished teaching; and
14	(16)	Adopting applicable rules and procedures.
15	(b)	If, in accordance with chapter 92, the board
16	determine	s, on a case-by-case basis, that extenuating

18	temporari:	ly suspend its rules, or any portion thereof. The
