A BILL FOR AN ACT

RELATING TO HIGHWAYS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 291C, Hawaii Revised Statutes, is
- 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 "\$291C- Medium-speed electric vehicles; speed;
- 5 restrictions. (a) A medium-speed electric vehicle shall not be
- 6 operated at a speed of more than thirty-five miles per hour.
- 7 (b) A medium-speed electric vehicle shall not be driven on
- 8 a highway that has a posted speed limit of more than forty-five
- 9 miles per hour. This subsection does not prohibit a medium-
- 10 speed electric vehicle from crossing a highway that has a posted
- 11 speed limit of more than forty-five miles per hour at an
- 12 intersection.
- (c) A medium-speed electric vehicle shall have a notice of
- 14 the operational restrictions applying to the vehicle permanently
- 15 attached to or painted on the vehicle in a location that is in
- 16 clear view of the driver.

         (d) The director of transportation shall adopt rules

         SECTION 2. Section 291C-1, Hawaii Revised Statutes, is

    amended by adding a new definition to be appropriately inserted
 6
    and to read as follows:

          ""Medium-speed electric vehicle" means any self-propelled,

    electrically powered four-wheeled motor vehicle with a roll cage
 9
    or hard surface body design, which is designed to be operated at
    speeds of thirty-five miles per hour or less."

         SECTION 3. Section 286-41, Hawaii Revised Statutes, is

    amended by amending subsection (b) to read as follows:

              Application for the registration of a vehicle shall

    be made upon the appropriate form furnished by the director of

    finance and shall contain the name, occupation, and address of
    the owner and legal owner; and, if the applicant is a member of

    the United States naval or military forces, the applicant shall
    give the organization and station. All applications shall also

    contain a description of the vehicle, including the name of the

    maker, the type of fuel for the use of which it is adapted

    (e.g., gasoline, diesel oil, liquefied petroleum gas), the

- 1 manufacturer or dealer, and such further description of the
- 2 vehicle as is called for in the form, and such other information
- 3 as may be required by the director of finance, to establish
- 4 legal ownership. A person applying for initial registration of
- 5 a neighborhood electric vehicle or medium-speed electric vehicle
- 6 shall certify in writing that a notice of the operational
- 7 restrictions applying to the vehicle as provided in section
- 8 291C-134 or 291C- , as may be applicable, are contained on a
- 9 permanent notice attached to or painted on the vehicle in a
- 10 location that is in clear view of the driver."
