A BILL FOR AN ACT

RELATING TO VETERAN BURIAL GRANTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that a Filipino veteran
2	of the New Filipino Scouts who enlisted between October 6, 1945,
3	and June 30, 1947, died after June 30, 1994, and at the time of
4	the veteran's death, was a United States citizen and a resident
5	of the State of Hawaii, is entitled to receive a burial grant
6	from the office of veterans' services to pay for the cost of:
7	(1) Providing funeral and burial services for the deceased
8	veteran; and
9	(2) Transporting the remains of the deceased veteran to
10	the Philippines.
11	To qualify for this burial grant, however, the Filipino
12	veteran's survivor or an interested party must produce an
13	itemized paid invoice showing the specific services rendered on
14	behalf of the deceased veteran. However, because of the
15	tremendous upfront costs associated with funeral and burial
16	services as well as transportation to the Philippines, some
17	World War II Filipino veterans, and their families and friends,
18	cannot afford to pay for these activities in advance. SB626 SD1.DOC

1 Consequently, some World War II Filipino veterans will not be 2 able to qualify for these burial grants from the office of 3 veterans' services. Because of these financial constraints, the 4 bodies of some deceased veterans were not properly buried until 5 the deceased veteran's survivor or interested parties raised the 6 necessary funds to pay for funeral and other related services. 7 The legislature further finds that under the Veterans 8 Benefits and Health Care Improvement Act of 2000 (Public Law 9 106-419), many of the Filipino World War II veterans previously **10** eligible to participate in the state office of veterans' 11 services program regarding transportation of remains to the **12** Philippines are now eligible to be interred in state and federal 13 veterans' cemeteries. Therefore, in fairness to those veterans' 14 survivors who are not offered reimbursement for those 15 transportation costs, the payments made under this Act are 16 properly limited to only those veterans of the New Filipino

- 16 SECTION 2. Chapter 363, Hawaii Revised Statutes, is
- 17 amended by adding a new section to be appropriately designated
- 18 and to read as follows:
- 19 "\$363- Disbursement of World War II Filipino veterans
- 20 burial grant funds. (a) At the request of a deceased Filipino
- 21 veteran's survivor or an interested party, the office shall

- 4 SECTION 3. There is appropriated out of the general
- 5 revenues of the State of Hawaii the sum of \$ or so much
- $\mathbf{6}$ thereof as may be necessary for fiscal year 2009-2010 and the
- 7 same sum or so much thereof as may be necessary for fiscal year
- 8 2010-2011 for burial grant funds for deceased Filipino veterans.
- 9 The sums appropriated shall be expended by the department
- 10 of defense, office of veterans' services for the purposes of
- 11 this Act.
- 12 SECTION 4. New statutory material is underscored.
- 13 SECTION 5. This Act shall take effect upon its approval;
- 14 provided that section 3 shall take effect on July 1, 2009.
