## A BILL FOR AN ACT

RELATING TO THE CONDITION OF LAND.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 663, Hawaii Revised Statutes, is 2 amended by adding a new section to be appropriately designated 3 and to read as follows: 4 Landowner duty to inspect; rockslides; natural "§663-5 hazards. (a) A land occupier or landowner shall have a continuing duty to inspect, or cause to be inspected, the land 6 7 owned by the landowner or occupied by the land occupier, as 8 applicable, for risk of rockslide or landslide or the presence 9 of natural or man-made hazard; provided that the inspection 10 shall be made at a frequency and at intervals as appropriate to the measure of the risk, as is reasonable under the 11
- 12 <u>circumstances.</u>

  (b) A land occupier or landlord, as applicable under
- 14 subsection (a), shall keep written records of each inspection;
- provided that the written records shall be admissible as
- evidence in any court proceeding relating to any claim of

- 3 (c) This section shall not be deemed to preclude a county
- 4 from adopting ordinances not less stringent than contained in
- 5 this section.
- 6 As used in this section:
- 7 "Land occupier" means a person who occupies, resides on, or
- 8 utilizes land or real estate of a landowner pursuant to a
- 9 written lease agreement.
- 10 "Landowner" means the possessor of a fee simple absolute
- 11 title in land or real estate and shall include the State and its
- 12 political subdivisions in their capacities as owners of public
- lands.
- "Landslide" means the rapid downward movement of a mass or
- 15 rock, earth, or artificial fill on a slope.
- 16 "Man-made hazard" means a condition of the land created by
- 17 an element of human intent, negligence, or error that may cause
- 18 a rockslide, landslide, or other disaster.
- 19 "Natural hazard" means biological, geological,
- 20 hydrological, or seismic conditions that may cause a rockslide,
- 21 landslide, or other disaster, including a hazard potential as
- defined in section 179D-3.

1	"Reasonable under the circumstances" means an effort made
2	under reasonably foreseeable circumstances that would prevent a
3	rockslide, landslide, or natural or man-made hazard from causing
4	harm, including but not limited to:
5	(1) Personal injury or death to persons coming onto the
6	land, or coming onto or occupying surrounding land; or
7	(2) Property damage to surrounding land.
8	"Rockslide" means:
9	(1) The usual rapid downward movement of detached segments
10	of hillside or bedrock; or
11	(2) The rock mass that has reached its current position
12	through erosion."
13	SECTION 2. This Act does not affect rights and duties that
14	matured, penalties that were incurred, and proceedings that were
15	begun, before its effective date.
16	SECTION 3. New statutory material is underscored.
17	SECTION 4. This Act shall take effect upon its approval.

### Report Title:

Rockslides; Natural Hazards; Man-Made Hazards; Duty to Inspect

### Description:

Imposes on a landowner or land occupier a continuing duty to inspect the property for risk of rockslide, landslide, and for natural hazards and man-made hazards that could result in harm to persons or property.
