## A BILL FOR AN ACT

RELATING TO THE RENTAL MOTOR VEHICLE AND TOUR VEHICLE SURCHARGE TAX.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Section 251-2, Hawaii Revised Statutes, is
  amended to read as follows:

  "\$251-2 Rental motor vehicle and tour vehicle surcharge
  tax. (a) There is levied and shall be assessed and collected
- 5 each month a rental motor vehicle surcharge tax of \$2 a day,
- 6 except that for the period of September 1, 1999, to August 31,
- 7 2011, the tax shall be [\$3] \$ a day, or any portion of
- 8 a day that a rental motor vehicle is rented or leased [-]:
- 9 provided that of the foregoing surcharge tax amount, \$3 shall be
- deposited into the state highway fund pursuant to section 248-9,
- 11 and any amount collected in excess of \$3 shall be deposited into
- 12 the general fund. The rental motor vehicle surcharge tax shall
- 13 be levied upon the lessor; provided that the tax shall not be
- 14 levied on the lessor if:
- 15 (1) The lessor is renting the vehicle to replace a vehicle
- of the lessee that is being repaired; and

1	(2)	A record of the repair order for the vehicle is
2	÷	retained either by the lessor for two years for
3		verification purposes or by a motor vehicle repair
4		dealer for two years as provided in section 437B-16.
5	(b)	There is levied and shall be assessed and collected
6	each mont	h a tour vehicle surcharge tax of:
7	(1)	[\$65] \$ for each tour vehicle used or
8		partially used during the month that falls into the
9		over twenty-five passenger seat category; and
10	(2)	[\$15] \$ for each tour vehicle used or
11		partially used during the month that falls into the
12		eight to twenty-five passenger seat category[-];
13	provided	that of the monthly tour vehicle surcharge tax amount
14	assessed	and collected for each tour vehicle pursuant to
15	paragraph	(1), \$65 shall be deposited into the state highway
16	fund unde	r section 248-9, and any amount collected in excess of
17	\$65 shall be deposited into the general fund; provided further	
18	that of t	he monthly tour vehicle surcharge tax amount assessed
19	and colle	ected for each tour vehicle pursuant to paragraph (2),
20	\$15 shall	be deposited into the state highway fund under section
21	248-9, and any amount collected in excess of \$15 shall be	
22	deposited into the general fund.	

- 1 The tour vehicle surcharge tax shall be levied upon the
- 2 tour vehicle operator."
- 3 SECTION 2. Statutory material to be repealed is bracketed
- 4 and stricken. New statutory material is underscored.
- 5 SECTION 3. This Act shall take effect on July 1, 2009.
