A BILL FOR AN ACT

RELATING TO THE STATE OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that this Act is
2	instrumental in reducing costs and facilitating greater
3	efficiency in government.
4	SECTION 2. Except for positions in the department of
5	education; the University of Hawaii system; the Hawaii health
6	systems corporation; the department of commerce and consumer
7	affairs; correctional programs in the department of public
8	safety; and developmental disabilities, adult mental health
9	inpatient, adult mental health outpatient, and child and
10	adolescent mental health programs in the department of health
11	(1) per cent of the positions vacated in each
12	department may be refilled by the head of the
13	department to ensure the continued ability of the
14	department to carry out its public purpose;
15	(2) per cent of the positions vacated in each
16	department shall be:

1	(A)	Held vacant for fiscal year 2009-2010 and shall
2		be assigned to a statewide personnel pool;
3		provided that after June 30, 2010, the governor
4		may propose the transfer of per cent of
5		the vacant positions assigned to the statewide
6		personnel pool between executive departments as
7		necessary to fill essential positions, subject to
8		approval by the legislature through the executive
9		budget; and
10	(B)	Held vacant for fiscal year 2010-2011 and shall
11		be assigned to a statewide personnel pool;
12		provided that after June 30, 2011, the governor
13		may propose the transfer of per cent of
14		the vacant positions assigned to the statewide
15		personnel pool between executive departments as
16		necessary to fill essential positions, subject to
17		approval by the legislature through the executive
18		budget; and
19	(3)	per cent of the positions vacated in each
20	depa	rtment shall be eliminated.
21	SECTION 3	. With respect to positions in the judiciary:

1	(1)	per cent of the positions vacated may be		
2		refilled by the chief justice to ensure the continued		
3		ability of the judiciary to carry out its public		
4		purpose;		
5	(2)	per cent of the positions vacated in each		
6		department shall be held vacant for fiscal		
7		years 2009-2010 and 2010-2011; and		
8	(3)	per cent of the positions vacated shall be		
9		eliminated.		
10	SECTION 4. Funding allocations for positions vacated and			
11	refilled pursuant to this Act shall be computed on the basis of			
12	the average monthly salary of the department from which the			
13	person separated, and shall be distributed accordingly. All			
14	amounts already allocated for positions vacated pursuant to this			
15	Act shall be returned to the general fund. Each department			
16	shall report its position reallocations to the director of			
17	finance, who shall report this information to the legislature n			
18	later than twenty days prior to the convening of the regular			
19	sessions of 2010 and 2011.			
20	SECTION 5. This Act shall take effect on July 1, 2009.
