A BILL FOR AN ACT

RELATING TO TAXATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to increase the income tax check-offs in support of public education and public 2 3 libraries. 4 SECTION 2. Section 235-102.5, Hawaii Revised Statutes, is 5 amended by amending subsections (b) and (c) to read as follows: 6 "(b) Notwithstanding any law to the contrary, any 7 individual whose state income tax refund for any taxable year is 8 [\$2] \$ or more may designate [\$2] \$5, \$10, or any 9 other whole dollar amount of the refund to be deposited into the **10** school-level minor repairs and maintenance special fund 11 established by section 302A-1504.5, when submitting a state **12** income tax return to the department. In the case of a joint 13 return of a husband and wife having a state income tax refund of 14 [\$4] \$\perp \text{or more, each spouse may designate that } [\\$2] 15 \$5, \$10, or any other whole dollar amount of the refund be deposited into the special fund. The director of taxation shall 16 **17** revise the individual state income tax return form to allow the
