A BILL FOR AN ACT

RELATING TO AFFORDABLE HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that in 2008, the Urban 2 Land Institute Hawaii (Institute) published the results of a study on affordable housing in Hawaii. The data was not 3 encouraging: in 2008, only four per cent of the population could 4 5 afford to purchase a median-priced single-family home with one median salary, and only twenty-four per cent could afford a home 6 7 with up to two median salaries. In an effort to bring reality to the numbers, the Institute asked: How many elementary school 8 9 teachers does it take to purchase a median-priced home in 10 Honolulu? 3.63. How many firefighters? 3.19. How many civil 11 engineers does it take to rent a three bedroom dwelling in 12 Honolulu? 1.31.

13 The legislature further finds that while these statistics 14 may be recent, the problem of affordable housing in Hawaii is an 15 old one. The problem is further complicated by a number of 16 other factors, including the interdependency of various laws and 17 regulations. Well-intended efforts to streamline a specific

1 procedure may have unintended consequences on a related
2 requirement. As a result, initiatives to fast track and
3 increase the development of affordable housing often fall short.
4 The purpose of this Act is to direct the legislative
5 reference bureau to review state laws related to affordable
6 housing to identify strategies to strengthen Hawaii's housing
7 laws.

8 SECTION 2. (a) The legislative reference bureau shall 9 review state laws related to affordable housing, in particular, 10 chapter 201H, Hawaii Revised Statutes, relating to the Hawaii 11 housing finance and development corporation, and chapter 356D, 12 Hawaii Revised Statutes, relating to the Hawaii public housing 13 authority, to recommend strategies to strengthen Hawaii's 14 housing laws, including:

15 (1) Identifying duplicative or overlapping provisions in
16 current law that may hamper the increased development
17 of affordable housing;

18 (2) Reviewing concerns raised regarding proposed
19 amendments to Hawaii's housing laws that were intended
20 to increase the development of affordable housing,
21 which were introduced in the 2008 and 2009 legislative
22 sessions;
