A BILL FOR AN ACT

RELATING TO AFFORDABLE HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that in 2008, the Urban Land Institute Hawaii published the results of a study on 2 affordable housing in Hawaii. The data was not encouraging: 3 in 4 2008, only four per cent of the population could afford to 5 purchase a median-priced single-family home with one median 6 salary and only twenty-four per cent could afford a home with up 7 to two median salaries. In an effort to bring reality to the 8 numbers, the Institute asked: How many elementary school 9 teachers does it take to purchase a median-priced home in 10 Honolulu? 3.63. How many firefighters? 3.19. How many civil 11 engineers does it take to rent a three bedroom dwelling in 12 Honolulu? 1.31.

13 The legislature further finds that while these statistics
14 may be recent, the problem of affordable housing in Hawaii is an
15 old one. The problem is further complicated by a number of
16 other factors, including the interdependency of federal, state,
17 and county laws and regulations. Well-intended efforts to

streamline a state procedure may have unintended consequences on
 a related county requirement. As a result, initiatives to fast
 track and increase the development of affordable housing often
 fall short.

5 The purpose of this Act is to direct the legislative
6 reference bureau to review the state and county laws related to
7 affordable housing to identify strategies to strengthen Hawaii's
8 housing laws.

9 SECTION 2. (a) The legislative reference bureau shall 10 review the state and county laws related to affordable housing, 11 in particular chapter 201H, Hawaii Revised Statutes, relating to 12 the Hawaii housing finance and development corporation; chapter 13 356D, Hawaii Revised Statutes, relating to the Hawaii public 14 housing authority; and chapter 46, Hawaii Revised Statutes, 15 relating to county organization and administration, to recommend 16 strategies to strengthen Hawaii's housing laws, including:

17 (1) Identifying duplicative or overlapping provisions in
18 current law that may hamper the increased development
19 of affordable housing;
