BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

3	<u>(d)</u>	Allows a dogfight to occur on any property owned or
4		controlled by the person;

9	<u>(f)</u>	Uses any means of communication for the promotion of a

Statutory material to be repealed is bracketed 18 and stricken. New statutory material is underscored.

SECTION 4. This Act shall take effect on January 1, 2010.
