### A BILL FOR AN ACT

RELATING TO CHILDREN.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The department of human services shall SECTION 1. (a) 2 establish a three-year pilot project to develop and operate 3 statewide emergency care, hanai ohana care, and specialized 4 learning facilities for endangered and disadvantaged children. 5 For the purposes of this Act and pursuant to Senate Concurrent 6 Resolution No. 189 (2004), the department shall cooperate with 7 Malama O Kamalii Makamae, a nonprofit organization devoted to assisting needy children. In particular, the pilot project 8 9 shall focus on assisting native Hawaiian children younger than 10 thirteen years of age who are homeless or from low-income 11 households, pursuant to House Concurrent Resolution No. 189 12 (2007), and newborns abandoned in the State, pursuant to Act 7, 13 Special Session Laws of Hawaii 2007.

14 (b) The pilot project shall assist children whose
15 physical, emotional, mental, social, or educational well-being
16 is in imminent danger. This assistance shall come in the form
17 of offering safe havens for children in crisis, supplying health

1	care and j	proper nutrition, and providing social and educational
2	services.	Specifically, the pilot project shall:
3	(1)	Offer medical examinations upon a child's arrival at a
4		safe haven or emergency facility;
5	(2)	Schedule educational activities at safe havens or
6		emergency facilities; and
7	(3)	Provide pilot project staff and Malama O Kamalii
8		Makamae employees with training to address the special
9		needs of the children. The department of human
10		services may consult with the department of health,
11		the department of education, or any other appropriate
12		agencies to develop and facilitate staff and employee
13		training.
14	(c)	In addition to subsection (b), the pilot project may
15	provide s	ervices or develop programs that provide assistance to
16	homeless,	low-income, and native Hawaiian children, as the pilot

19	including chapter 171, Hawaii Revised Statutes, the department
