A BILL FOR AN ACT

RELATING TO TOXIC PRODUCTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that phthalates, a class
- 2 of chemicals used in polyvinyl chloride plastic to improve
- 3 product flexibility and in cosmetics to adhere a fragrance to a
- 4 product, are also used in many products intended for use by
- 5 infants and young children, including teethers, toys, and soft
- 6 plastic books. There is extensive scientific evidence reporting
- 7 the hormone-disrupting effect of phthalates and the dangerous
- 8 phthalates levels found in humans. Studies show that virtually
- 9 everyone carries some level of phthalates in their body due, in
- 10 part, to oral ingestion of the chemicals.
- 11 The purpose of this Act is to prohibit the manufacture,
- 12 sale, or distribution of certain toys and child care articles
- 13 containing bisphenol-A or specific types of phthalates in
- 14 concentrations exceeding 0.1 per cent and to require
- 15 manufacturers to use safer alternatives when replacing
- 16 phthalates in their products.

1 SECTION 2. The Hawaii Revised Statutes is amended by 2 adding a new chapter to be appropriately designated and to read 3 as follows: 4 "CHAPTER 5 **PHTHALATES** 6 -1 Definitions. As used in this chapter: 7 "Child care article" means any product designed or intended by the manufacturer to facilitate the sleep, relaxation, 8 9 feeding, sucking, or teething of children under the age of 10 three. 11 "Phthalates" or "phthalate esters" means the group of 12 chemical compounds that is used mainly to plasticize soft plastic polyvinyl chloride bath toys, teething rings, bath 13 14 books, and other toys and child care articles for infants and 15 young children. 16 "Toy" means any product designed or intended by the 17 manufacturer to be used by a child at play. 18 -2 Prohibition of manufacture, sale, or distribution. 19 Beginning January 1, 2010, no person or entity shall
