A BILL FOR AN ACT

RELATING TO MAKUA.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The Hawaii Revised Statutes is amended by 2 adding a new chapter to be appropriately designated and to read 3 as follows: 4 "CHAPTER 5 MAKUA VALLEY RESERVE 6 § -1 Administration of chapter. The Makua valley reserve commission and the department of land and natural 7 8 resources shall administer this chapter. 9 -2 Definitions. As used in this chapter, unless the 10 context otherwise requires: 11 "Commission" means the Makua valley reserve commission. 12 "Department" means the department of land and natural 13 resources. "Valley reserve" means the area designated on the island of 14 15 Oahu as Makua valley, including the three ahupuaa of Kahanahaiki, Makua, and Koi'ahi. 16

1	§ -3 Reservation of uses. (a) The valley reserve shall
2	be used solely and exclusively for the following purposes:
3	(1) Preservation and practice of all rights customarily
4	and traditionally exercised by native Hawaiians for
5	cultural, spiritual, and subsistence purposes;
6	(2) Preservation and protection of its archaeological,
7	historical, and environmental resources;
8	(3) Rehabilitation, revegetation, habitat restoration, and
9	preservation; and
10	(4) Education.
11	(b) The valley reserve shall be reserved in perpetuity for
12	the uses enumerated in subsection (a). Commercial uses shall be
13	strictly prohibited.
14	§ -4 Powers and duties. The department and other
15	departments and agencies of the State shall be subject to the
16	oversight of the commission with regard to the control and
17	management of the valley reserve. Subject to section -6, the
18	department shall:
19	(1) Implement controls and permitted uses for the valley
20	reserve;
21	(2) Enforce this chapter;
22	(3) Provide administrative support to the commission; and

1	(4)	Authorize those of its employees as it deems
2		reasonable and necessary, to serve and execute
3		warrants, arrest offenders, or issue citations in all
4		matters relating to enforcement of the laws and rules
5		applicable to the valley reserve.
6	§	-5 Commission. (a) There is established the Makua
7	valley re	serve commission to be placed within the department for
8	administr	ative purposes as provided in section 26-35. The
9	commissio	n shall consist of nine members to be appointed in the
10	manner an	d to serve for the terms provided in section 26-34;
11	provided	that:
12	(1)	One member shall be a member of Malama Makua;
13	(2)	One member shall be a member of Hui Malama O Makua;
14	(3)	One member shall be a representative of families that
15		were evicted from the valley reserve or whose lands in
16		the valley reserve were condemned by the federal
17	•	government;
18	(4)	One member shall be appointed by the governor from a
19		list provided by the Waianae coast community;
20	(5)	One member shall be a trustee or representative of the
21		office of Hawaiian affairs;

1	(6)	One member shall be the commanding officer of the
2		United States Army, Pacific, or the commanding
3		officer's designee;

- 4 (7) One member shall be the adjutant general of the State, 5 or the adjutant general's designee;
- 6 (8) One member shall be the chairperson of the board of7 land and natural resources; and
- 8 (9) One member shall be appointed by the governor from a9 list provided by native Hawaiian organizations.
- 10 (b) The governor shall appoint the chairperson from among11 the members of the commission.
- 12 (c) The members of the commission shall serve without pay
 13 but shall be reimbursed for their actual and necessary expenses,
 14 including travel expenses, incurred in carrying out their
 15 duties.
- (d) Any action taken by the commission shall be approved by a simple majority of its members. Four members shall constitute a quorum to do business.
- 19 (e) The commission, without regard to the requirements of 20 chapters 76 and 77, may hire employees, including an executive 21 director, necessary to perform its duties.

1	§	-6 Responsibilities and duties of the commission. The
2	general a	dministration of the valley reserve shall rest with the
3	commissio	n. In carrying out its duties and responsibilities,
4	the commi	ssion:
5	(1)	Shall establish criteria, policies, and controls for
6		permissible uses within the valley reserve;
7	(2)	Shall approve all contracts for services and rules
8		pertaining to the valley reserve;
9	(3)	Shall provide advice to the governor, the department,
10		and other departments and agencies on any matter
1		relating to the valley reserve;
12	(4)	Shall provide advice to the office of planning and the
13		department of the attorney general on any matter
14		relating to the federal conveyance of the valley
15		reserve;
16	(5)	May enter into curator or stewardship agreements with
17		appropriate Hawaiian cultural and spiritual community
18		organizations for the perpetuation of native Hawaiian
19		cultural, religious, and subsistence customs, beliefs,
20		and practices for the purposes stated in section -3;
21	(6)	Shall carry out those powers and duties otherwise

conferred upon the board of land and natural resources

1		and the land use commission with regard to
2		dispositions and approvals pertaining to the valley
3		reserve. All powers and duties of the board of land
4		and natural resources and the land use commission
5		concerning dispositions and approvals pertaining to
6		the valley reserve are transferred to the commission;
7	(7)	Shall carry out those powers and duties concerning the
8		valley reserve otherwise conferred upon the city and
9		county of Honolulu by chapter 205A. The powers and
10		duties of the city and county of Honolulu and its
11		agencies concerning coastal zone dispositions and
12		approvals pertaining to the valley reserve are
13		transferred to the commission;
14	(8)	Shall carry out those powers and duties concerning the
15		valley reserve otherwise conferred upon the island
16		burial councils and the department with regard to
17		proper treatment of burial sites and human skeletal
18		remains found in the valley reserve;
19	(9)	Shall adopt rules in accordance with chapter 91 that
20		are necessary for the purposes of this chapter and
21		shall maintain a record of its proceedings and

actions; and

1	(10) May delegate to the executive director or employees of
2	the commission, by formal commission action, such
3	power and authority vested in the commission by this
4	chapter as the commission deems reasonable and proper
5	for the effective administration of this chapter.
6	§ -7 Interim activities of the commission. Prior to the
7	return of the valley reserve from the United States Army to the
8	State, the commission may enter into discussions with the United
9	States Army to facilitate the expedient return of the valley
10	reserve upon the expiration of the United States Army's lease.
11	§ -8 Penalty. Any person who violates any of the laws
12	or rules applicable to the valley reserve shall be guilty of a
13	petty misdemeanor and shall be fined not more than \$1,000 or
14	imprisoned not more than thirty days, or both, for each offense
15	Each day of each violation shall be deemed a separate offense.
16	§ −9 General administrative penalties. (a) Except as
17	otherwise provided by law, the commission may set, charge, and
18	collect administrative fines, or bring legal action to recover
19	the administrative costs of the commission or the department, or
20	payment for damages, or for the cost to correct damages
21	resulting from a violation of this chapter or any rule adopted
22	thereunder. The administrative fines shall be as follows:

- 3 (2) For a second violation within five years of a previous
 4 violation, by a fine of not more than \$15,000; and
- 5 (3) For a third or subsequent violation within five years 6 of the last violation, by a fine of not more than 7 \$25,000.
- In addition, an administrative fine of up to \$5,000 8 9 may be levied for each specimen of natural resource or any 10 historic property taken, killed, injured, broken, or damaged in 11 violation of any rule adopted under this chapter. For purposes 12 of this section, "natural resource" includes any archaeological 13 artifacts, minerals, any aquatic life or wildlife or parts 14 thereof, including eggs, and any land plants or parts thereof, 15 including seeds. Also for purposes of this section, "historic 16 property" means any building, structure, object, districts,
- 19 (c) Any criminal penalty for any violation of this chapter
 20 or any rule adopted under this chapter shall not be deemed to
 21 preclude the commission from bringing a civil legal action to
 22 recover additional administrative fines and costs. Any civil

- 2 and costs for any violation of this chapter or any rule adopted
- 3 under this chapter shall not be deemed to preclude the State
- 4 from pursuing any criminal action against that person.
- 5 (d) In any judicial proceeding to recover an
- 6 administrative penalty imposed, the commission need only show
- 7 that notice was given, that a hearing was held or the time
- 8 granted for requesting a hearing has run without such a request,
- 9 that an administrative penalty was imposed, and that the
- 10 administrative penalty remains unpaid.
- 11 § -10 Transfer. Upon its return to the State, the
- 12 resources of the valley reserve shall be held in trust as part
- 13 of the public land trust; provided that the State shall transfer
- 14 management and control of the valley reserve to the sovereign
- 15 native Hawaiian entity upon its recognition by the United States
- 16 and the State.
- 17 All terms, conditions, agreements, and laws affecting the
- 18 valley reserve, including any ongoing obligations relating to
- 19 the clean-up of the valley reserve, shall remain in effect
- 20 unless expressly terminated.
- 21 § -11 Makua valley rehabilitation trust fund. (a)
- 22 There is created in the state treasury a trust fund to be



- 1 designated as the Makua valley rehabilitation trust fund to be
- 2 administered by the department with the prior approval of the
- 3 commission. Subject to this chapter, all moneys received from
- 4 the federal government for the rehabilitation and environmental
- 5 restoration of the valley reserve, any moneys appropriated by
- 6 the legislature to the trust fund, any proceeds from
- 7 administrative fines imposed and collected under this chapter,
- 8 and the interest or return on investments earned from moneys in
- 9 the trust fund, shall be deposited in the trust fund and shall
- 10 be used to fulfill the purposes of this chapter.
- 11 (b) The commission may use moneys in the trust fund to
- 12 carry out the purposes of this chapter, including hiring
- 13 employees, specialists, and consultants necessary to complete
- 14 projects related to the purposes of this chapter.
- (c) Moneys deposited into or appropriated to the trust
- 16 fund shall remain available until they are obligated or until
- 17 the trust fund is repealed.
- 18 (d) The trust fund shall be repealed on July 1, 2045. The
- 19 commission shall transfer to the credit of the state general
- 20 fund, all unexpended or unencumbered balances remaining in the
- 21 trust fund prior to June 30, 2045; provided that all unexpended



- 1 or unencumbered balances of federal moneys shall be disbursed in
- 2 accordance with applicable federal law.
- 3 § -12 Severability. If any provision of this chapter or
- 4 the application thereof to any person or circumstance is held
- 5 invalid, the invalidity shall not affect other provisions or
- 6 applications of this chapter that can be given effect without
- 7 the invalid provision or application, and to this end the
- 8 provisions of this chapter are severable."
- 9 SECTION 2. It is the express intent of the legislature and
- 10 this Act not to obstruct, deny, or revoke any rights or
- 11 privileges heretofore exercised by the United States Army in its
- 12 use of Makua valley throughout the term of its lease.
- 13 SECTION 3. This Act shall take effect upon its approval.
