RELATING TO THE OFFICE OF COMMUNITY SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

| 15 | to be a policy objective of the highest priority. |

         SECTION 4. The sixteen permanent full-time equivalent

    (16.0 FTE) positions in the office of community services are

    hereby transferred from the department of labor and industrial
