BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 286-102.6, Hawaii Revised Statutes, is 2 amended by amending subsection (b) to read as follows: 3 The provisional license shall entitle the provisional 4 licensee to drive the class of motor vehicles specified in 5 subsection (a) upon the roadways of the State; provided that: 6 The provisional licensee shall have the provisional (1)7 license in the provisional licensee's immediate 8 possession while driving; 9 (2) All occupants of the motor vehicle shall be restrained **10** by safety belts or a child passenger restraint system as required under sections 291-11.5 and 291-11.6; 11 12 (3) The provisional licensee shall not transport more than 13 one person under the age of eighteen, unless the 14 person is, with respect to the provisional licensee: 15 (A) A household member; or 16 A household member's foster or hanai child, **17** without being accompanied and supervised by a licensed

1		driver who is the provisional licensee's parent or
2		guardian; [and]
3	(4)	Except as provided in subsection (c), whenever the
4		provisional licensee is driving between the hours of
5		11:00 p.m. and 5:00 a.m., a licensed driver who is the

8		as the licensee, shall be in the motor vehicle and

Highway; Safety; Distracted Driving; Motor Vehicle

Description:

Prohibits persons aged fifteen years and six months but less than eighteen years of age from engaging in various tasks that distract from the primary task of driving such as, the use of all cell phones (including hands-free devices) and all other electronic devices, consuming food or beverages, engaging in personal grooming (i.e., applying makeup, brushing teeth or shaving), or attempting to reach for any other object or device, while operating a motor vehicle under either a temporary instruction permit or a provisional license.

TITLE:

A BILL FOR AN ACT RELATING TO HIGHWAY

SAFETY.

PURPOSE:

To prohibit persons aged fifteen years of age and six months or older, but less than eighteen years from engaging in various tasks that may distract from the primary task of driving such as: (1) the use of all cell phones (including hands-free) and all other electronic devices; (2) consuming food or beverages; (3) engaging in personal grooming (i.e., applying makeup, brushing teeth, or shaving); or (4) attempting to reach for any other object or device, while operating a motor vehicle under either a temporary instruction permit or a provisional license.

MEANS:

Amend sections 286-102.6(b) and 286-110, Hawaii Revised Statutes.

JUSTIFICATION:

Lack of driving experience and immaturity may make younger drivers more prone to accidents while driving. Young drivers engaging in various tasks not associated with operating a motor vehicle such as using cell phones or other electronic devices, consuming food or beverages, engaging in personal grooming (i.e., applying makeup, brushing teeth or shaving), or attempting to reach for any object or device, while driving may be distracted and could be more prone to accidents. Based on data obtained by the National Highway Traffic Safety Administration, distractions while driving due to other tasks were reported in 33 percent of the crashes, and 27 percent of near crashes.

Furthermore younger drivers, under the age of 20, were more likely than drivers of other ages to have been distracted at the

time of their crashes (12 to 14 percent versus 6 to 9 percent). In general, distracted drivers were 50 percent more likely to have been seriously injured or killed in their crashes, as compared to attentive drivers. Also, distracted drivers were more likely than attentive drivers to have been involved in single-vehicle or rear-end crashes.

The State of Hawaii crash data indicates that between the years of 2001 through 2005, there were a total of 31,515 motor vehicle crashes resulting in injuries. Of those 31,515 injury-producing crashes, a total of 2,134, or 6.8 percent of those crashes involved a driver between the ages of 15 through 17 years old. During the same time period, there were a total of 22,270 property damage only crashes, of which 1,400, or 6.3 percent of those crashes, involved a driver between the ages of 15 through 17 years old.

Impact on the public: Younger drivers between the ages of 15% through 17 years old that are prohibited from undertaking various, non-driving tasks while driving, should be less distracted while operating a vehicle, thereby increasing their ability to concentrate on driving. In turn, the roadway will be safer for all other roadway users (i.e., other drivers, pedestrians, bicyclists, etc.).
