## SENATE CONCURRENT RESOLUTION

REQUESTING A TRANSITION PLAN FOR THE TRANSFER OF THE HAWAII STATE PUBLIC LIBRARY SYSTEM FROM THE BOARD OF EDUCATION TO THE DEPARTMENT OF ACCOUNTING AND GENERAL SERVICES.

1 WHEREAS, concerns have been expressed about the current 2 placement of the Hawaii State Public Library System under the 3 management of the Board of Education; and 4

5 WHEREAS, these concerns include differences in mission from 6 the Department of Education, which may make the libraries' 7 projects lesser in priority compared to the Department of 8 Education's projects and responsibilities, and differences in 9 service populations, where the library system serves a broader 10 community while schools focus on public education for 11 adolescents and children; and

13 WHEREAS, the Department of Accounting and General Services 14 currently processes accounting and payroll work for the library 15 system and the two agencies currently collaborate on library 16 repair and maintenance and new construction projects, and there 17 would be few remaining administrative duties to transfer from 18 the Department of Education to the Department of Accounting and 19 General Services; and

21 WHEREAS, a large part of the library system's functions 22 centers on maintaining and improving library facilities, which 23 is a better fit and is currently under the Department of 24 Accounting and General Services, which performs a large amount 25 of facilities management and improvement functions; and 26

WHEREAS, the Department of Accounting and General Services' resources and work on the neighbor islands would be particularly helpful in facilitating the improvement of library facilities, which are especially important in smaller communities; now, therefore,

BE IT RESOLVED by the Senate of the Twenty-fifth 1 Legislature of the State of Hawaii, Regular Session of 2010, the 2 House of Representatives concurring, that the Hawaii State 3 Public Library System and the Department of Accounting and 4 General Services are requested to develop a transition plan for 5 a proposed transfer of the Hawaii State Public Library System 6 from administration by the Board of Education to the Department 7 of Accounting and General Services; and 8 9

10 BE IT FURTHER RESOLVED that the transition plan may 11 consider factors such as the Hawaii State Public Library 12 System's ability to achieve its mission under administration by 13 the Board of Education versus the Department of Accounting and 14 General Services, any cost savings that may be realized by a 15 transfer, and the advantages and disadvantages of a transfer; 16 and

BE IT FURTHER RESOLVED that the Hawaii State Public Library System and the Department of Accounting and General Services are requested to submit their transition plan to the Legislature no later than twenty days prior to the convening of the 2011 Regular Session; and

24 BE IT FURTHER RESOLVED that certified copies of this 25 Concurrent Resolution be transmitted to the State Librarian, the 26 Superintendent of Education, the Chairperson of the Board of 27 Education, and the Comptroller.
