# A BILL FOR AN ACT

RELATING TO THE STATEWIDE TRAFFIC CODE.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 Section 291C-41, Hawaii Revised Statutes, is 2 amended to read as follows: 3 "[+] §291C-41[+] Drive on right side of roadway; exceptions. (a) Upon all roadways of sufficient width a 4 vehicle shall be driven upon the right half of the roadway, 5 except as follows: 6 7 When overtaking and passing another vehicle proceeding (1) in the same direction under the rules governing such 9 movement; 10 (2) When an obstruction exists making it necessary to 11 drive to the left of the center of the highway; provided any person so doing shall yield the right-of-12 way to all vehicles traveling in the proper direction 13 upon the unobstructed portion of the highway within 14 such distance as to constitute an immediate hazard; 15 16 (3) Upon a roadway divided into three marked lanes for traffic under the rules applicable thereon; or 17

- 3 Upon all roadways any vehicle proceeding at less than 4 the normal speed of traffic at the time and place and under the 5 conditions then existing shall be driven in the right-hand lane then available for traffic, or as close as practicable to the 6 7 right-hand curb or edge of the roadway, except when overtaking 8 and passing another vehicle proceeding in the same direction or 9 when preparing for a left turn at an intersection or into a 10 private road or driveway.
  - (c) Upon any roadway having four or more lanes for moving traffic and providing for two-way movement of traffic, no vehicle shall be driven to the left of the center line of the roadway, except when authorized by official traffic-control devices designating certain lanes to the left side of the center of the roadway for use by traffic not otherwise permitted to use such lanes, or except as permitted under subsection (a)(2). This subsection shall not be construed to prohibit the crossing of the center line in making a left turn into or from an alley, private road, or driveway.
- 21 (d) No motor vehicle with a gross vehicle weight rating of 22 26,001 or more pounds shall be driven in the far left lane of

3	(1) It is necessary for the driver of the motor vehicle to
4	follow traffic control devices that direct use of a

6	(2) The right half of a roadway is closed to traffic while
7	under construction or repair."
8	SECTION 2. This Act does not affect rights and duties that
9	matured, penalties that were incurred, and proceedings that were
10	begun before its effective date.
11	SECTION 3. Statutory material to be repealed is bracketed
12	and stricken. New statutory material is underscored.

SECTION 4. This Act shall take effect upon its approval.
