RELATING TO TRANSIENT ACCOMMODATIONS TAX.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the State needs a
2	better reporting system with respect to transient accommodations
3	tax revenues collected from residential properties. Better
4	reporting will enable the State to collect transient
5	accommodations taxes with improved efficiency and identify
6	transient vacation rental and bed and breakfast operations that
7	are not reporting revenues subject to the transient
8	accommodations tax.
9	The purpose of this Act is to, among other things:
10	(1) Authorize the department of taxation to share records
11	and information with the counties to identify
12	transient vacation rental and bed and breakfast
13	operations within their respective jurisdictions; and
14	(2) Authorize the counties to share records and
15	information pertaining to transient vacation rentals
16	and bed and breakfast establishments operating within
17	their respective jurisdiction with the department of
18	taxation to ensure compliance with applicable

14	(b) Each county department or agency charged with the

3	(c) For the purposes of this section:
4	"Transient vacation rental" means the same as "transient
5	accommodations" as the term is defined in, and is subject to

7	accommodations not reside at the real property where the
8	transient accommodations are provided.
9	"Bed and breakfast accommodations" means the same as
10	"transient accommodations" as the term is defined in, and is
11	subject to chapter 237D; provided that the owner or owners of

13	provided reside on the real property where the transient
14	accommodations are provided."
