begs leave to report as follows:

Your Committee received testimony in support of the nomination of Gerald Yamada from the Department of Commerce and Consumer Affairs, the Chair of the Contractors License Board, and BIA-Hawaii.

Upon review of the testimony, your Committee finds that the nominee's professional experience, commitment to public service, and proven leadership on the Contractors License Board qualify him for reappointment to the Contractors License Board. Your Committee notes that Gerald Yamada has been licensed since 1987 as a painting contractor, and subsequently obtained licensure in general engineering, general building, and several other specialty classifications. As Chairperson of the Board's Scope of Work Committee, he serves an important role in guiding the Board through the process of defining the work that may be performed



under the various license classifications. Your Committee further finds that this nominee has been reappointed to the Contractors License Board based on his knowledge, experience, and commitment to public service.

Your Committee received testimony in support of the nomination of Randall B.C. Lau from the Department of Commerce and Consumer Affairs, the Chair of the Contractors License Board, BIA-Hawaii, and one private citizen.


