Your Committee on Tourism, Culture, & International Affairs, to which was referred H.B. No. 1224 entitled:

"A BILL FOR AN ACT RELATING TO WORKS OF ART SPECIAL FUND,"

begs leave to report as follows:

The purpose of this bill is to:

- Suspend until June 30, 2011, the transfer of one percent of all capital improvement project appropriations to the Works of Art Special Fund (Special Fund); and
- (2) Transfer any unexpended and unencumbered moneys in the Special Fund on June 30, 2009, to the appropriate capital projects fund to be allotted and expended for capital improvement projects.

The Department of Accounting and General Services testified in support of the intent of this bill. A concerned individual opposed this measure.

Your Committee has amended this bill by:

- Changing its effective date to July 1, 2112, to encourage further discussion; and
- (2) Making technical, nonsubstantive amendments for clarity, consistency, and style.
