Your Committee on Ways and Means, to which was referred H.B. No. 242, H.D. 1, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO AGRICULTURE,"

begs leave to report as follows:

The purpose of this measure is to appropriate funds for the planning and repairing of agricultural facilities at the former Del Monte operation on Oahu and at Maui Community College.

This measure also authorizes the issuance of an unspecified amount of general obligation bonds to modify the facilities at the former Del Monte operation and Maui Community College, to improve the value-added agricultural industry.

Your Committee received three written comments on this measure. The written comments may be reviewed on the Legislature's website.

Your Committee finds that diversified agriculture contributes to the State's economy by providing employment opportunities and products for export, and by promoting tourism. Your Committee also finds that successful agricultural ventures would not only result in significant contributions to the State's economy, but also help to stabilize and sustain Hawaii's food supply. Your Committee further finds that the investment of resources to support value-added agricultural operations is a necessary step to

foster a successful transition from plantation agriculture to diversified agriculture.

Your Committee has amended this measure by replacing the unspecified bond issuance amount with an amount of \$1 of general obligation bonds to facilitate further discussion on the measure.
