"A BILL FOR AN ACT RELATING TO PUBLIC SAFETY,"

begs leave to report as follows:

The purpose of this bill is to assist the State in determining the most effective and efficient means of spending its resources on corrections by requiring a correctional impact statement to be attached to any bill that proposes a change in the law that will:

- (1) Create a new offense;
- (2) Significantly change an existing offense or the penalty for an existing offense; or
- (3) Change existing sentencing, parole, or probation procedures.

The Hawaii Government Employees Association, American Civil Liberties Union of Hawai'i, Community Alliance on Prisons, Drug Policy Forum, African American Lawyers Association, and a concerned individual testified in support of this bill. The Department of Public Safety and Hawaii Paroling authority submitted comments on this measure.
