Your Committee on Water, Land, & Ocean Resources, to which was referred S.B. No. 1318, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO PLANNING AND ECONOMIC DEVELOPMENT,"

begs leave to report as follows:

The purpose of this bill is to reorganize the State's longterm planning and coastal zone management by:

- (1) Repealing Chapter 205A, Hawaii Revised Statutes (HRS), the coastal zone management law;
- (2) Abolishing the Office of Planning by repealing Chapter 225M, HRS; and
- (3) Transferring all rights, powers, functions, and duties of OP to the Department of Business, Economic Development, and Tourism (DBEDT).

The Office of Planning, Department of Land and Natural Resources, Department of Agriculture, Maui Tomorrow Foundation, Inc., Livable Hawaii Kai Hui, Hanalei-Haena Community Association, Sierra Club, Hawaii Chapter, Ocean Tourism Coalition, Structural Engineers Association of Hawaii, Surfrider Foundation, National States Geographic Information Council, the Representative of the

17<sup>th</sup> House District, and numerous concerned individuals opposed this measure.

Your Committee has amended this bill by removing its substance and replacing it with the substance of H.B. No. 593, H.D. 2, a bill that was reported out of your Committee earlier this session. As amended, this bill:

- Allows DLNR to establish a interim coastal construction moratorium along Kailua Beach where appropriate for the long-term protection of the beach; and
- (2) Takes effect on July 1, 2020.
