Your Committee has amended this measure by inserting language  
to appropriate federal Reed Act funds for workforce development  
initiatives as follows:

- (1) As seed monies to the Department of Labor and Industrial  
Relations;
- (2) To provide funds to assist the State's four local  
workforce investment boards; and
- (3) To provide funds to Oahu's workforce investment board.


Prior to amending this measure, a proposed S.D. 1 was
