Your Committee on Labor, to which was referred S.B. No. 2174 entitled:

"A BILL FOR AN ACT RELATING TO THE EMPLOYEES' RETIREMENT SYSTEM,"

begs leave to report as follows:

The purpose of this measure is to include county representation in the Board of Trustees of the Employees' Retirement System.

Specifically, this measure replaces one citizen/non-employee of the State member with a county representative member who is appointed by the Hawaii Council of Mayors.

Testimony in support of this measure was submitted by one private organization. Written testimony presented to the Committee may be reviewed on the Legislature's website.

Your Committee finds that the counties contribute a considerable share to retirement system costs, and their employees and retirees are a significant portion of the System's membership. As such, your Committee believes that it is appropriate to include county representation on the Employee's Retirement System Board of Trustees. County representation will ensure that the Board possesses expertise about county finances and the county workforce in making benefit decisions. Lack of representation may result in a situation where Board members do not fully consider the impact of their actions on the counties, resulting in changes that may
